PROVISION OF A ONCE OFF SERVICE MAINTENANCE FOR NAVIGATIONAL AID EQUIPMENT AT POLOKWANE INTERNATIONAL AIRPORT.

1. PURPOSE:

The purpose of this service request is to invite quotations for a once off maintenance services for the navigational aid equipment at Polokwane International Airport.

2. BACKGROUND:

GAAL seeks to appoint the services of reputable, experienced service provider for a once off maintenance services for the navigational aid equipment at Polokwane International Airport in line with SACAA requirements.

3. REQUIRED SERVICES

The services required are as follows:

- ❖ The provision of navigational aids equipment DVOR/ DME maintenance.
- ❖ Provide a list of components which require repairs.
- ❖ Provide maintenance on the status monitoring system which is already installed at the airport.
- ❖ Provision of cleaning the equipment areas.

4. BIDDER'S OBLIGATIONS

Access permits for the employees deployed at the airport should be obtained from the airport at the cost of the service provider.

5. SPECIAL REQUIREMENTS

- Service provider must have at least five (5) years of experience in air traffic and navigation service management and accredited to provide approach control services.

4.6. I, the undersigned, who is duly authorised to do so on behalf of the company/firm, certify that the points claimed, based on the specific goals as advised in the tender, qualifies the company/ firm for the preference(s) shown and I acknowledge that:

- i) The information furnished is true and correct;
- ii) The preference points claimed are in accordance with the General Conditions as indicated in paragraph 1 of this form;
- iii) In the event of a contract being awarded as a result of points claimed as shown in paragraphs 1.4 and 4.2, the contractor may be required to furnish documentary proof to the satisfaction of the organ of state that the claims are correct;

- iv) If the specific goals have been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the organ of state may, in addition to any other remedy it may have –
- (a) disqualify the person from the tendering process;
 - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.
