1. GENERAL SUBMISSION

- 1.1.** RFQ proposals must reach CHIETA before the closing date and time as specified above and be emailed to procurement@chieta.org.za
- 1.2.** RFQ proposal received after the closing date and time will not be considered and will be returned to bidder.
- 1.3.** Bidders may not seek or obtain the assistance of employees CHIETA in the preparation of their proposal's responses.

2. PAYMENT

- 2.1.** CHIETA will pay the Contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by the CHIETA to the Contractor.
- 2.2.** The Contractor shall from time to time during the duration of the contract, invoice CHIETA for the services rendered.
- 2.3.** The invoice must be accompanied by supporting source document(s) containing detailed information, as CHIETA may require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.
- 2.4.** No payment will be made to the Contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to CHIETA.
- 2.5.** Payment shall be made by bank transfer into the Contractor's back account normally 30 days after receipt of an acceptable, original, valid tax invoice. Money will only be transferred into a South African bank account (CHIETA will affect payment only on accounts verified and appear on Central Supplier Database.)
- 2.6.** The Contractor shall be responsible for accounting to the appropriate authorities for its income tax, VAT or other moneys required to be paid in terms of the applicable law.

1. INTRODUCTION

CHIETA is an entity of government and subscribes to the principles of good corporate governance, which requires conducting business in an honest and transparent manner in line with the provisions of the Public Finance Management Act (PFMA). In line with the above, CHIETA has adopted various policies whose objective is to achieve sound financial management, to strengthen a culture of honesty, reliability, transparency, and care amongst all its internal and external stakeholders. www.chieta.org.za

2. PURPOSE

The purpose of this bid is to solicit proposals from suitable and qualified bidders for the appointment of a Public Relations (PR) services for a period of 24 months effective from



01 April 2025 to managed and enhance the overall image of the CHIETA, build and maintain key relations with stakeholders and facilitate effective communication.

3. PROEJCT SCOPE

The successful bidder will be required to deliver the following PR in collaboration with CHIETA's Stakeholder Liaison Unit:

3.1.Crisis Communication

- **Plan Development:** Collaborate with CHIETA to create a proactive crisis communication plan, including key messaging templates, decision-making protocols, and an escalation matrix for crisis scenarios.
- **Crisis Simulations:** Conduct crisis management workshops and simulations to ensure preparedness among stakeholders.
- **Real-Time Support:** Provide 24/7 support during a crisis to manage media inquiries, draft public statements, and mitigate reputational damage.

3.2.Stakeholder Engagement

- **Mapping and Analysis:** Identify and analyse key stakeholders, categorising them by influence and interest to tailor engagement strategies.
- **Strategic Engagement:** Develop personalised engagement approaches, such as one-on-one meetings, webinars, or roundtable discussions, to foster trust and communication.
- **Feedback Mechanism:** Implement systems to capture stakeholder feedback, analyse it, and incorporate insights into future PR efforts.

3.3. Reputation Management

- **Monthly Reputational Monitoring:** Track and assess CHIETA's public image and sentiment through media analysis and stakeholder feedback.
- **Proactive Initiatives:** Implement thought leadership activities, media appearances, and strategic campaigns to strengthen CHIETA's reputation.
- **Issues Management:** Promptly address negative sentiment or misinformation to mitigate reputational risks.

3.4.PR Strategy and Content Development

- **Strategy Development:** Develop and execute PR strategies, including monthly plans, media monitoring, and reports.
- **Monthly Writing Deliverables:** Deliver the following written outputs each month: Three (3) press releases or two (2) press releases and one (1) opinion



piece and Six (6) ad hoc write-ups, including speeches, talking points, and briefing notes.

- **Clippings and Reports:** Provide comprehensive monthly clippings and performance measurement reports with metadata and analysis for all PR print, broadcast, and online coverage.
- **Meetings and Reporting:** Conduct weekly meetings, maintain minutes of meetings, and provide status reports.
- **Project Management:** Assign a dedicated project manager to oversee deadlines, content delivery, and media query management.

3.5. Media Plan Development and Execution

- **Annual Media Plan:** Develop a comprehensive media plan with a calendar of press conferences, media briefings, and releases.
- **Media Kits:** Create media kits, including press releases, fact sheets, and multimedia resources.
- **Media Relationships:** Build and maintain strong relationships with journalists, editors, and media outlets to secure positive coverage.

3.6. Podcast Planning and Execution

- Collaborate with CHIETA to plan, produce, and distribute podcast sessions featuring key industry topics and thought leaders. Sessions x 6 for the year.

3.7. Impact Measurement and Reporting

- **Tools and Metrics:** Use industry-standard tools to measure PR performance, including engagement metrics, reach, and sentiment analysis.
- **Detailed Reporting:** Provide detailed monthly reports with insights and recommendations.

4. PROJECT TIMEFRAMES

The services stated above will need to be rendered over a period of 24-month period commencing on the date of the signing of the SLA, subject to annual review of service provider's performance.

5. CONFIDENTIALITY

All information relating to the submissions, through the process or otherwise shall be treated in strict confidentiality.

4. EVALUATION AND SELECTION CRITERIA

The CHIETA has set minimum standards (Gates) that bidders must meet to be considered. All quotations duly lodged as specified in the Request for Quotation will be examined to determine compliance with quotation requirements and conditions. Quotations with obvious deviations from the requirements/conditions will be eliminated from further consideration. Below criteria will be used to assess individual bidders' proposals.

CHIETA will conduct screening of mandatory documents to check whether bidders meet compliance requirements. Failure to submit the required documentation below as referenced will lead to disqualification.

4.2. GATE 2- TECHNICAL ASSESSMENT

- 4.2.1. **Provide company profile detailing business services offering, Company's core business should be 90% in media and communication.**
- 4.2.2. The company must be at least (5) years and above in rendering similar services
- 4.2.3. A minimum of five (5) contactable reference letters indicating similar experience in providing public relations management services in medium to big corporate as per the scope of work and/or similar within Public and/Private sector. Reference letters must be for work conducted within the last two (2) to Ten (10) years and must be dated and signed in the referring company's letterhead. CHIETA shall conduct extensive reference checks.
- 4.2.4. Detailed project methodology and plan with clear timelines as per the scope of work including the list of resources that will be deployed rendering the required services (CHIETA at its discretion will invite bidders to make representations)

4.3. GATE 3: PRICE AND PREFERENCE

- The bidders that have successfully progressed through to STAGE 3 will be evaluated in accordance with the **80/20** Preference Point System as contemplated in the Preferential Procurement Regulations 2017 where bidder with highest score on price and preference will be awarded.
- If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining quotations.
- The point scored for the B-BBEE status level certificate for each acceptable quotation will now be added to the price point.
