JCPZ currently operates 2 crematoria that are classified as a listed activity in terms of Section 21 of the National Environmental Management: Air Quality Act (No. 39 of 2004) (NEM: AQA). The relevant listed activity is Subcategory 8.2 (Crematoria and Veterinary Waste Incineration). South African legislation (NEM: AQA) requires that the operation of a listed activity be subjected to the conditions of an Atmospheric Emission License (AEL). One of these is regular emission testing to prove compliance with emission limits contained in Government Notice 893 (commonly known as the Minimum Emission Standards).

JCPZ intends to appoint a competent service provider to assist the municipality to conduct stack emission measurements as per the Department of Environmental (DEA) requirements on ***three stacks*** at Lenasia Crematorium for Subcategory 8.2. All emission tests must be conducted in accordance with the methods prescribed in Annexure A of Government Notice 893.

The preferred service provider will be required to compile a SHE file in line with the requirements of JPCZ's SHEQ department.
