1. BACKGROUND

Emergency Services utilises electrical equipment at all Emergency Services facilities 24-hour that need to be maintained and repaired when broken.

These personnel are working shifts and need to store and prepare their food during 12-hour shifts. Laundry appliances are needed for washing of operational wear and PPE when needed.

The personnel need to timeously report broken appliances to comply with hygiene and OHS requirements.

2. PROJECT SCOPE

It is the intent of the City of Tshwane that these specifications cover the repair and maintenance of electrical kitchen and laundry appliances utilised in the Emergency Services Department on an as and when required basis for a period not exceeding 12 months.

All replacement items shall be new and of the highest quality. They shall be protected from damage; any damaged, flawed or defaced materials shall be rejected and replaced at a cost to the service provider.

The bidder shall warrant that the materials shall be of the highest grade, in accordance with the best practices and ready and complete for full operation. The bidder shall warrant that all the materials / goods supplied under the contract are new and unused.

The bidder shall further warrant that all materials / goods supplied under tender award shall have no defect, arising from design, materials, or workmanship or from any act or omission of the bidder that may develop under normal use of the supplied goods.

The full scope which includes the repair and maintenance of electrical kitchen and laundry appliances will be awarded to one service provider and for ease of evaluation, all bid proposals shall be submitted in the same order as these specifications.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

 - b. reject the bid of any bidder if that bidder or any of its directors has abused the supply chain management system of the municipality or municipal entity or has committed any improper conduct in relation to such system; and
 - c. cancel a contract awarded to a person if the person committed any corrupt or fraudulent act during the bidding process or the execution of the contract.
- 4 This MBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.
- 5 In order to give effect to the above, the attached Certificate of Bid Determination (MBD 9) must be completed and submitted with the bid:

¹ Includes price quotations, advertised competitive bids, limited bids and proposals.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.
