### 4. POINTS AWARDED FOR B-BBEE STATUS LEVEL OF CONTRIBUTOR

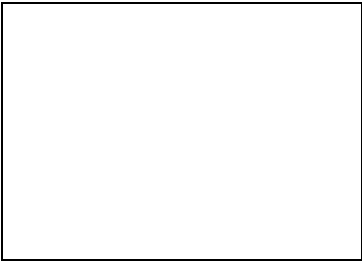
