Scope of Works	1. Project Background The South African National Energy Development Institute (SANEDI) was established under the National Energy Act, Act No. 34 of 2008, to direct, monitor and conduct energy research and development, promote energy efficiency, and support energy technology innovation in South Africa. SANEDI is mandated by the Department of Electricity and Energy (DEE) to implement, monitor and evaluate the South African Energy Efficiency Standards and Labelling (S&L) Programme in collaboration with strategic partners including the National Regulator for Compulsory Specifications (NRCS), the South African Bureau of Standards (SABS), and the Department of Trade, Industry and Competition (the dtic). As part of the S&L Programme, the VC9008 compulsory specification for energy efficiency and labelling of electrical and electronic apparatus introduced Minimum Energy Performance Standards (MEPS) and mandatory energy efficiency labelling requirements for household refrigerators and combination fridge-freezers. Refrigeration appliances are among the most energy-intensive household appliances in South Africa and contribute significantly to residential electricity consumption. The implementation of VC9008 sought to reduce national electricity demand, improve consumer awareness, stimulate market transformation toward energy-efficient technologies, and contribute toward greenhouse gas emission reductions.

SANEDI intends to appoint a suitably qualified service provider to conduct an Ex-post Regulatory Impact Assessment (RIA) of the VC9008 regulation for the period 2020–2025. The study will assess the effectiveness, efficiency, environmental impact, socio-economic outcomes, market transformation effects, and implementation challenges associated with the regulation.

The findings of the study will support evidence-based policy refinement, future regulatory improvements, and strategic decision-making for the continued implementation of appliance energy efficiency regulations in South Africa.

2. Project Objectives:

1. Assess the effectiveness of the VC9008 regulation in improving the energy efficiency performance of household refrigerators and combination fridge-freezers in South Africa.
2. Quantify the energy savings achieved between 2020 and 2025 as a result of the implementation of Minimum Energy Performance Standards (MEPS) and energy efficiency labelling requirements.
3. Estimate the associated greenhouse gas (GHG) emission reductions resulting from reduced electricity consumption and refrigerant-related impacts.
4. Assess market transformation impacts, including changes in appliance efficiency classes, product availability, technology adoption, imports, and consumer purchasing trends.
5. Evaluate the socio-economic impacts of the regulation, including:
 - impacts on manufacturers, importers, distributors and retailers;
 - employment impacts across the appliance value chain; and
 - participation and opportunities for Small, Medium and Micro Enterprises (SMMEs).
6. Assess levels of regulatory compliance, enforcement effectiveness, and stakeholder awareness relating to VC9008 requirements.
7. Identify implementation challenges, regulatory gaps, unintended consequences, and opportunities for improvement.
8. Provide evidence-based recommendations to strengthen future appliance energy efficiency regulations and implementation mechanisms.

3. Scope of Works

The appointed service provider will be required to undertake the following activities:

3.1 Inception Phase

- Conduct a project inception meeting with SANEDI and relevant stakeholders.
- Review all available background documentation related to VC9008 and the S&L Programme.

- Develop and submit an Inception Report detailing:
 - proposed project plan and methodology;
 - stakeholder engagement approach;
 - data collection tools;
 - project work plan;
 - timelines and milestones;
 - risk management approach.

3.2 Data Collection and Stakeholder Engagement

The service provider collects both quantitative and qualitative data relevant to the implementation of VC9008 for household refrigerators and combination fridge-freezers between 2020 and 2025.

Activities shall include:

- Review of SANEDI programme records and NRCS Letters of Authority (LoA) data.
- Review of market surveillance and compliance information.
- Collection and analysis of:
 - appliance sales data;
 - product performance data;
 - energy efficiency class data;
 - import and export data;
 - consumer and industry trends.
- Conduct stakeholder consultations with:
 - manufacturers;
 - importers;
 - retailers;
 - industry associations;
 - testing laboratories;
 - government stakeholders; and
 - selected consumers.

Conduct surveys, interviews and/or focus group discussions where necessary

3.3 Data Analysis and Impact Assessment

The service provider shall analyze collected data to assess:

a) Energy and Environmental Impacts

- Energy savings are attributable to VC9008 implementation.
- Estimated electricity cost savings.
- Greenhouse gas emission reductions associated with electricity savings and refrigerant impacts.

b) Market Transformation Impacts

- Changes in appliance efficiency classes and product offerings.
- Uptake of energy-efficient refrigeration appliances.
- Technology and innovation trends within the market.

c) Socio-economic Impacts

- Employment impacts across the value chain.
- Participation and opportunities for SMMEs.
- Consumer affordability and awareness impacts.

d) Regulatory and Compliance Assessment

- Compliance trends and enforcement effectiveness.
- Key implementation challenges and barriers.
- Regulatory gaps and unintended consequences.

e) Counterfactual Assessment

- Develop a comparative scenario illustrating likely market and energy outcomes in the absence of VC9008 implementation.

3.4 Reporting

The service provider shall prepare and submit:

- Inception Report.
- Data Collection and Stakeholder Engagement Report.
- Draft Ex-post RIA Report.
- Final Ex-post RIA Report incorporating SANEDI comments.
- Executive Summary and Policy Brief.

The reports must include:

- methodology and assumptions;
- data sources;

- charts, graphs and visual analysis;
- findings and interpretation;
- conclusions and recommendations.

3.5 Stakeholder Presentation

- Present draft and final findings to SANEDI and relevant stakeholders.
- Incorporate stakeholder comments into the final report.

3.6 Handover Requirements

All raw datasets, survey tools, interview records, models, calculations, and supporting documents developed during the project shall be submitted to SANEDI upon project completion.

3.7 Proposed Data Collection Methods

The study should primarily utilize existing programme, regulatory and market data available from SANEDI, NRCS and relevant stakeholders, supplemented by targeted stakeholder engagements and limited primary data collection where necessary.

3.8 Confidentiality

The appointed service provider should treat all information and data received during the assignment as confidential and shall not disclose such information without prior written approval from SANEDI.

3.9 Intellectual Property

All reports, datasets, models, and supporting materials developed during the project shall remain the property of SANEDI.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 SANEDI reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the SANEDI.

2. DEFINITIONS

- (a) “tender” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “price” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “rand value” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the audi alteram partem (hear the other side) rule has been applied; and
- (e) forward the matter for criminal prosecution, if deemed necessary.
