APPOINTMENT OF A SERVICE PROVIDER TO PROVIDE A TWO DAY EQUITY AND SKILLS DEVELOPMENT TRAINING

This document sets out the Terms of Reference (TOR) for the appointment of a service provider to provide a 2 day workshop for the Equity and Skills Development training.

Background

The Employment Equity Act (EEA) requires a designated employer to comply with the act and regulations. The Skills Development Acts also require employers to consult on matters of skills development. It is therefore essential for the employer to equip the responsible committee on aspects of Equity and Skills development legislative frameworks, etc.

The HSRC is therefore looking to appoint a suitable service provider to conduct a workshop towards the appropriate skilling of its Employment Equity and Skills Committee (ESC) to ensure that the HSRC and the committee is fully compliant with all relevant legislative frameworks governing Employment Equity and Skills Development in the workplace.

Employment Equity Committee Training is essential if you want to avoid your company being fined up to 10% of your annual turnover for not complying with the Employment Equity Act. This training programme enables managers and consultation forums to work together effectively to ensure a constructive business transformation process. This course will enable participants to:

Nature of the Assignment

The facilitator should have a proven track record in Employment Equity and Skills Development, have an excellent command of the English language, be in possession of the necessary qualifications, and have the necessary experience to be able to engage with researchers and non-research staff.

The workshop should include the following

- Development of a common understanding of the ESC in relation to the Employment Equity and Skills Development Acts and the relevance of same within the context of the HSRC as employer and the linkage to BBBEE.
- Roles, functions and responsibilities of the ESC.
- Know how to provide a meaningful contribution as members of a committee and bringing important matters to the attention of the Executive.

- Best practice consultation and communication processes for the ESC.

Typically, the workshop focus areas should include aspects dealing with:

- The Employment Equity Act, regulations and the legislative requirements
- Understanding Discrimination
- Skills Development legislative framework and requirements
- Effective Committee Functioning
- A summary video on Employment Equity Management and Skills Development management best practices

The successful service provider must perform these Key responsibilities:

The appointed service provider is expected to:

- Demonstrate, through a detailed proposal outlining a clear methodology that it has the necessary skills, competencies, and experience to undertake this assignment.
- Provide evidence (including contactable references) of previous training in Employment Equity and Skills Development training.
- Demonstrate that it has an intimate understanding of the research environment and be willing to tailor-make and customize a training programme to suit the HSRC needs.
- Provide a report on the workshop a week after it has taken place.
- Provide certificate of attendance/ participation.

- The facilitator must have a relevant qualification; Masters degree will be an advantage
- The facilitator must have a minimum of 5 years' experience in facilitating or offering Employment Equity and Skills Development training workshops;
- The service provider must provide recent and traceable references for work done on Employment Equity and Skills Development;

- Ability to offer the workshop during the month of July 2021.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
