1. INTRODUCTION

The Moses Kotane Institute (MKI) is an entity of the KwaZulu-Natal Provincial Government through the Department of Economic Development, Tourism and Environmental Affairs (EDTEA) with a mandate to conduct world class research that responds to the needs of the provincial economy.

The MKI invites suitable service providers to submit proposals for the development of the revised Moses Kotane Institute business case.

2. SCOPE OF WORK

- Research and benchmarking of similar entities
- Completion of the business case to covering service delivery model, human resources, and core functions

3. REQUIRED COMPETENCES AND REQUIREMENTS

- Bidder must have a minimum experience of 3 years in similar assignments with extensive knowledge of business plan development.
- Bidder must submit a minimum of three reference letters in similar project.
