1. INTRODUCTION AND PURPOSE

This bid specification sets out the requirements of the City of Tshwane Roads and Transport Department for the appointment of a suitably qualified and experienced service provider to manage the City's Railway Safety Management System (SMS) in full compliance with the National Railway Safety Regulator Act 16 of 2002, as amended, and the 2018 SMS Determination issued under Section 28 thereof.

The appointed service provider will act on behalf of the City in all interactions with the Railway Safety Regulator (RSR) in respect of the Railway Safety Permit currently held by the City of Tshwane.

2. BACKGROUND

The City of Tshwane currently holds a railway safety permit issued by the Railway Safety Regulator (RSR). The current railway safety permit is due for renewal in September 2026. Under the 2018 SMS Determination made pursuant to Section 28 of the National Railway Safety Regulator Act 16 of 2002 (as amended), the City is obliged to maintain a fully documented and approved Railway Safety Management System.

The Roads and Transport Department has identified the need to appoint a specialist service provider to audit the current SMS, update it to comply with the latest RSR determinations, manage the RSR submission and approval process, and conduct physical condition and risk assessments of the City's railway infrastructure — including all level crossings.

3. DELIVERABLES/ PROJECT SCOPE

The successful bidder must submit a comprehensive project schedule within 10 business days of contract award, clearly indicating milestones, costs, timeframes, delivery dates, and a progress reporting schedule.

The following deliverables are required:

1. SMS Audit Report — a comprehensive, ECSA-signed audit report of the City's current SMS files assessed against RSR determinations, identifying gaps and non-conformances;
2. Updated Railway Safety Management System — the full updated SMS documentation aligned to the latest RSR determination, ready for RSR submission;
3. RSR Submission Confirmation and Approval — evidence of submission to RSR and the RSR written approval certificate;
4. Level Crossing Physical and Risk Assessment Report — a quantified risk assessment for all level crossings, compliant with SANS 3000-2-2-1: 2021, including a remediation priority schedule;
5. Infrastructure Condition Assessment Report — a data-driven condition assessment of all railway infrastructure assets, including a geo-referenced asset register, condition grading matrix, and maintenance procedure with prioritised remediation schedule and engineering cost estimates; and
6. Corrective Action Plans (CAPs) — following each RSR inspection/audit, a documented CAP with implementation timelines, signed off by a Pr. Eng.

4. VALIDITY PERIOD

The tender shall remain valid and binding for a period of ninety (90) days after the closing date.

5. STAGES OF EVALUATION

Bids will be evaluated in three sequential stages. A bid that fails any stage will not proceed to the next stage.

1. Administrative compliance
2. Mandatory compliance
3. Preference points

5.1 ADMINISTRATIVE COMPLIANCE

All the bids will be evaluated against the administrative responsiveness requirements as set out in the list of returnable documents.

5.2 MANDATORY REQUIREMENTS

The following mandatory requirements apply to this bid. Failure to meet any one of these requirements will result in disqualification and the bid will not be evaluated further.

5.2.1 ECSA Registration — Mandatory

1. The service provider must hold current registration with the Engineering Council of South Africa (ECSA) and valid certificate must be submitted
2. The lead engineer(s) assigned to this project hold ECSA-recognised engineering qualifications in a relevant discipline (e.g., civil or structural or mechanical engineering).

Proof required: At least Two (2) Pr. Civil Eng with Valid ECSA registration certificate for the service provider or the assigned Pr. Eng. or Pr. Tech. Eng.

5.2.2 Minimum Relevant Experience — Mandatory

1. The service provider must demonstrate a minimum of ten (10) years' directly relevant experience in all four (4) of the following:

- Railway infrastructure structural assessment or condition monitoring on active railway networks in South Africa
- Development, auditing, or updating of Railway Safety Management Systems compliant with RSR determinations;
- Structural health monitoring (SHM) of railway tunnels, bridges, or related infrastructure
- Physical and risk assessment of railway level crossings in accordance with SANS standards.

2. Proof required: Minimum of two (2) contactable reference letters from clients confirming relevant railway infrastructure or SMS work completed within the past ten (10) years, on the client's official letterhead.

5.2.3 RSR Interaction Experience — Mandatory

The service provider must demonstrate prior direct interaction with the Railway Safety Regulator (RSR) on behalf of a railway permit holder, including at minimum the preparation or submission of safety management documentation to the RSR.

Proof required:

- At least one (1) or more contactable reference confirming prior RSR engagement, or documentation showing previous RSR submission activity.
- At least eight (8) years' managerial working experience within railway safety regulator, conducting inspection and complying with inspection documents. Attach CV.

5.2.4 Quality Management Certification — Mandatory

The service provider must hold a valid, current ISO 9001:2015 certification (or equivalent internationally recognised quality management system certification) applicable to the services to be rendered under this contract.

Proof required: Valid, current ISO 9001:2015 certificate issued by an accredited certification body. The certificate must cover the scope of services relevant to this contract.

5.2.5 Health & Safety Grading — Mandatory

The service provider must demonstrate a current, active occupational health and safety management grading or certification (NOSA, ISO 45001, or equivalent recognised grading body) confirming fitness to operate on active railway infrastructure.

Proof required: Current, valid NOSA grading certificate, ISO 45001 certificate, or equivalent, not older than twelve (12) months at the time of bid submission.

5.2.6 Professional Indemnity Insurance — Mandatory

The service provider must hold current professional indemnity (PI) insurance with a minimum cover of R5,000,000 per claim, applicable to the professional engineering and safety management services to be rendered.

Proof required: Current professional indemnity insurance certificate or broker letter confirming cover, not older than three (3) months at time of submission.

5.3 PREFERENCE POINT SYSTEM

The preferential points to be used will be the 80/20 points system in terms of the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000) Regulations 2022.

6. CONDITION

6.1 The successful bidder shall comply with all applicable provisions of the National Railway Safety Regulator Act 16 of 2002 (as amended), the Occupational Health and Safety Act 85 of 1993, and all relevant SANS standards throughout the contract period.

6.2 All personnel deployed on the City of Tshwane's railway infrastructure must hold valid site-specific safety inductions and comply with the City's applicable health and safety requirements.

6.3 The successful bidder must maintain the same key personnel and subcontractors (if applicable) for the duration of the contract unless prior written approval is obtained from the City.

6.4 The successful bidder must provide monthly written progress reports to the City in a format approved by the Department.
