1. PURPOSE

The purpose of this Request for Quotation (RFQ) is to appoint a qualified service provider to conduct a 3-day Financial Management Training for 50 SMMEs in the Kruger National Park.

2. INTRODUCTION TO SANPARKS

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

The appointed Service Provider will be responsible for:

- Developing and delivering a comprehensive 3-day training programme on Finance Management for 50 SMMEs in Kruger National Park.
- Providing a qualified and experienced facilitator(s) to conduct the training.
- Supplying all required stationery for delegates (e.g., pens, notepads, training materials, printed manuals, etc.).
- Providing training materials in both hard copy and electronic format.
- Delivering training in English
- Issuing certificates of attendance upon completion.
- The Service Provider must submit a close-out report within 5 working days of completion, including attendance registers, training evaluation results, photographs, and summary of participant feedback.

3.1 Training Details

The training will be conducted at the following locations:

1. Skukuza
2. Mopani

3.2 Objectives:

- To provide face to face theoretical training on costing and tendering over a period of 3 days (weekdays).

3.3 Other Important Information to Note:

- Training will take place in Kruger National Park (Skukuza and Mopani) in March 2026. Training dates will be communicated with the successful bidder.
- SANParks will be responsible for providing the training venue.
- SANParks will be responsible for provision of refreshments for all delegates
- Facilitator travelling and accommodation costs will be incurred by the appointed service provider.
- Training material will be the property of the client.

3.4 Financial Management Training should cover the content below:

Introduction to Financial Management:

- Defining financial roles, goals (e.g., profit vs. wealth maximization),
- financial environment.

Accounting Principles & Financial Statements:

- Understanding the Balance Sheet, Income Statement, and
- Cash Flow Statement to analyze business health.

Financial Planning and Forecasting:

- Developing budgets,
- forecasting techniques, and
- establishing financial controls.

Working Capital Management:

- Managing short-term assets and liabilities,
- including cash, inventory, and
- accounts receivable/payable.

Capital Budgeting and Investment Appraisal:

Evaluating long-term investments using tools like Net Present Value (NPV), Internal Rate of Return (IRR), and payback period.

Cost Management and Control:

- Analyzing costs for decision-making,
- reducing waste, and
- improving efficiency.

Risk and Return:

- Identifying financial risks,
- understanding leverage, and
- measuring expected returns.

Financial Analysis Techniques:

Using ratio analysis (liquidity, profitability, efficiency) to assess performance.

NB: Training Provider is expected to provide a Training Plan / Implementation Plan that will illustrate what will be covered for each day as per the outline above. Practical exercises /examples are crucial in making sure that the training achieves the desired outcomes.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

3.1. POINTS AWARDED FOR PRICE

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

South African National Parks (SANParks) cannot amend the National Treasury’s General Conditions of Contract (GCC). SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.
