1. GENERAL TENDER CONDITONS

- 1.1 The conditions, specifications and schedules contained in this document form an integral part of the tender contract and must be returned with the tender submitted. Failure to comply herewith will invalidate a tender.
- 1.2 This document contains continuously numbered pages and is the copyright of the Municipality of George. It may not be used, copied or lent out except in the performance of this contract.
- 1.3 Tenderers should carefully inspect the document for completeness and legibility. Claims based on missing pages or illegible script will not be considered.
- 1.4 Telegraphic tenders will be considered, provided that the tender document is posted before the advertised closing time of tender. Proof of the date and time of posting shall be required. **FAX OFFERS WILL NOT BE VALID.**
- 1.5 Late, incomplete, open or unmarked tenders will not be considered.
- 1.6 Proof of posting will not be accepted as proof of delivery.
- 1.7 Tenders shall remain valid for 180 days after closing date of tender.
- 1.8 Written information only will be valid as amending or supplementing this contract. Verbal information will not be accepted as binding on Council or its officials.
- 1.9 Each tender must be submitted in a sealed envelope clearly endorsed "TENDER NO ENG 027/2021: THE SUPPLY AND DELIVERY OF ELECTRICAL STOCK: DISTRIBUTION TRANSFORMERS AND MINISUBSTATIONS" and addressed to The Municipal Manager, Municipality, PO Box 19, GEORGE, 6530, so as to reach him not later than the date and time advertised or be placed in the tender box situated at Supply Chain Management, The George Civic Centre (1st floor), York Street, George.

Tenders shall be valid from date of appointment for a three (03) year period and items will be ordered from the successful tenderers as and when required.
- 1.10 All prices quoted and all deposits or payments made shall be in the currency of the Republic of South Africa.
- 1.11 Tenders must be submitted on the schedule provided and completed and signed in all respects.
- 1.12 The lowest or any tender will not necessarily be accepted and Council reserves the right to accept any tender in whole or in part.
- 1.13 Any deviation or omissions from or additions to the specifications or additional or alternate items shall be detailed in the variation schedule. Deviations or omissions not speechified shall not be accepted.

Any additional particulars should be furnished in a separate letter by tenderers.
- 1.14 Tenderers must submit: the prices of all optional equipment separately, the terms and conditions of guarantee, delivery time, availability and prices of and discounts on spare parts, full descriptive literature and specifications, and choices where applicable.
- 1.15 Contract Price Adjustment:

1.15.1 Prices should remain firm for the period of the tender. Should the successful Tenderer wish to alter any tendered price during the currency of this tender, Council reserves the right to:

- i) Accept the amended price
- ii) Call new tenders for the affected items.
- iii) Negotiate prices with alternate suppliers.

1.15.2 Where prices are not firm, a formula using the SEIFSA indexes is to be used and the following shall apply:-

- i) Tendered prices shall be based on the latest published index figures.
- ii) The adjusted contract price shall be coupled to the tendered delivery times and not the actual delivery date (e.g. if the tendered delivery time is 6 months and the order is placed in August, contract adjustment shall be calculated with February as agreed completion month). The actual delivery time shall be used to adjust the contract price where delivery time is shorter than the tendered delivery time.
- iii) Should Council be of the opinion that prices have risen out of proportion; Council reserves the right to negotiate on the open market for provision of the goods.
- iv) Successful tenderers must submit on request all the applicable formulas, constants and factors required for calculating price adjustments.

1.16 All invoices submitted for payment shall be accompanied by a CPA calculation sheet clearly showing all calculations where prices are subject to adjustment.

1.17 Test Certificates:

Where applicable, test certificates will be required and tenderers must state the additional cost for the submission thereof, if any.

1.18 Brochures:

All additional information brochures etc. required or which the Contractor wishes to submit with or in support of his tender, shall be submitted in duplicate.

1.19 Defective materials:

Should materials or equipment be found defective within one year after being supplied, or unsatisfactory in any way, the Council may order such defects or unsatisfactory materials to be replaced free of cost and that such replacements be subjected to one year guarantee.

1.20 Value Added Tax:

All prices must INCLUDE 15% V.A.T.

1.21 Quantities:

The minimum quantities given are the minimum quantities per any one order. More than the minimum amount may be ordered and more than one order may be placed during the year. Tenderers are free to specify discounts for large quantities.

1.22 Samples:

If so required, samples MUST be submitted to the Director: Electro technical Services, Municipal Offices, Brick Road, George. If this clause is not complied with, tenders will not be considered. The samples of accepted tenders will be held for the whole of the contract period for reference.

Tenders must also clearly state whether samples are to be returned or whether they are FREE OR CHARGED. In the absence of an indication in this regard, samples will be retained without future responsibility.

1.23 Quality and Guarantee:

- 1.23.1 All goods supplied shall be equal in all respects to samples, patterns of specifications where such are provided and where no samples or patterns are exhibited, or specifications maintained, then the goods or materials shall be the best of their respective kinds.
- 1.23.2 Council reserves the right to inspect any goods at any time during the production, testing or commissioning stage and may accept or reject any goods in part or as a whole that do not comply with this specification.
- 1.23.3 Any deliveries not equal to samples and/or not in accordance with the Contract or otherwise unsatisfactory will be rejected, and such rejected goods will be held at the risk and experience of the Contractor and must, if required, be removed by him immediately on receipt of notification of rejection. The fact that no objection was made at the time goods were delivered shall not affect the Council's rights under this clause.
- 1.23.4 Council reserves the right to request test certificates for specified items. If the tested samples meet the specification, Council will pay all the cost of such test. If the tested samples fail to meet the specification, the supplier shall pay the costs of testing, as well as removing all defective articles that may have been delivered and replacing with acceptable items.
- 1.23.5 If any dispute arises between the Council and the Contractor in connection with the quality and guarantee of the goods, either party may give to the other notice, in writing, of the existence of such dispute, and the same shall there upon be referred to arbitration in South Africa to a person to be mutually agreed upon. The submission shall be deemed to be a submission to arbitration within the meaning of the arbitration within the meaning of the arbitration laws in force in the Republic of South Africa.
- 1.23.6 The risk on all goods purchased by the Council under the Contract shall remain with the Contractor until such goods have been delivered to the Council.
- 1.23.7 The Form of Tender, Variation Schedule and Price Adjustment Schedule shall be completed by the Tenderer, and shall be submitted with his Tender on the tender closing date.
- 1.24 Delay in completion:
Should the Contractor fail to complete the delivery to the satisfaction of the Engineer within the period stated the Contractor shall pay the Employer as and for agreed liquidated damages the sum of 1/14% (one fourteenth percent) of the total contract amount per calendar day which sum the contractor agrees to forfeit for each and every calendar day the delivery remains incomplete after the expiration of the given period, and it is hereby agreed that in the above event the Employer shall have the right to realize all or any of the securities and apply the proceeds towards the payment of any claim under this or any other clause of these conditions of the contract. When the total of the abovementioned penalties reaches 5% of the contract value and the delivery is still incomplete, the Employer shall exercise procedures as set out in the General Conditions of Contract.
- 1.25 Escalation fees:
In the event of prices being subject to adjustment, such escalation fees shall only be payable up to and including the last day stated in the delivery schedule for items being delivered late.
- 1.26. A successful tenderer shall be notified of the award of a tender in writing, signed by the Municipal Manager or the Head of Department responsible for the contract. A verbal notification of award shall not be accepted as binding on the City Council of George.

ALL TENDERS THAT DO NOT COMPLY WITH THE ABOVEMENTIONED REQUIREMENTS WILL BE TAKEN AS INCOMPLETE AND MAY BE REJECTED WITHOUT FURTHER CONSIDERATION.

TECHNICAL SPECIFICATIONS

A. DISTRIBUTION TRANSFORMERS

1. General Requirements

- 1.1 Transformers shall comply with the requirements of SANS 780 and NRS 005 and **shall carry the SABS mark** together with the relevant specification number on the outside of the tank.

Newly manufactured transformers are required.

Re-built transformers will not be accepted.

Only Copper windings will be accepted.

Aluminium windings will not be accepted.

- 1.2 With reference to Appendix A of NRS 005 the following requirements shall apply:

1.2.1 Construction Requirements

- 1.2.1.1 16kVA & 25kVA single phase transformers and 25kVA 3-phase transformers shall be suitable for mounting on single wood poles.

- 1.2.1.2 16kVA to 500kVA transformers shall be of the outdoor type and hermetically sealed by means of welded covers.

- 1.2.1.3 800kVA and 1000kVA transformers shall be of the indoor type.

- 1.2.2 Bushings for transformers up to and including 500kVA shall be provided with arcing horns.

- 1.2.3 Refer to Section 3, Clause C for rated powers. Transformers shall be of the low loss type.

- 1.2.4 The rating of the low voltage neutral terminal shall be at least 50% of the rated current of the line terminals.

- 1.2.5 Rated voltages: 11000/420/242 volt.

- 1.2.6 Vector Group: Dyn11

- 1.2.7 Insulation level: 95kV

- 1.2.8 The earthing method for both MV and LV system: solid.

- 1.2.9 The prospective three phase MV fault level: minimum 12kA.

- 1.2.10 All distribution transformers shall be provided with a MV off-circuit tapping switch which can be externally operated to vary the nominal voltage ratio by plus and minus 2 ½% and 5%.

2. Specific Requirements

- 2.1. The complete tank of the 16kVA up to 50kVA transformers, including cooling tubes and radiator fins, as well as any fixing brackets, shall be galvanised in accordance with the requirements of SANS 763, or of 3CR12 steel. The rating plate must specifically indicate material as "Galvanised to SANS 763" or "CR12."

- 2.2 The 800kVA and 1000kVA transformers shall have bolted covers.

- 2.3 100kVA up to and including 1000kVA transformers shall have skid underbases.

- 2.4 100kVA up to and including 500kVA transformers shall have mounting brackets for standard lightning arresters.

- 2.5 Open bushings shall be provided for MV and LV external connections, unless otherwise specified (Refer to Clause 3.4 below).

- 2.6 Tenderers shall take note of Appendix B of NRS 005.

- 2.7 MV and LV bushings shall be on opposite sides of the tank except for the 16kVA and 25kVA single-phase transformers.

- 2.8 Only the 16kVA and 25kVA single-phase pole-mounted transformers shall have MV and LV cycloaliphatic bushings mounted on adjoining sides of the tank or at 90° for a circular tank.

- 2.9 Transformers shall be externally painted as follows: -

Paint finish:

Primer: Calcium Plumbate (24 hours drying)

1st Coat: Chlorinated Rubber

2nd Coat: Chlorinated Rubber

The colour of enclosures shall be C12 "AVOCADO" in accordance with SANS 1091.

3. MV CABLE END BOXES (OPTIONAL)

Only when specified, MV cable end boxes shall take the place of open bushings. Cable end boxes must be suitable for the termination of 3 Core PILC 6.35/11kV cable up to 185mm², with optional compound filling or heat shrink boxes. To ease pricing in the bill of quantities, please offer all switchgear with heat shrink termination boxes and at the end of list of applicable items the additional charge for using compound filled boxes instead of heat shrink boxes. The description of the two types of cable end boxes are as follows:

3.1 OPTION 1:

The type used for heat shrink terminations must be fully enclosed with a removable lid. Four (4) 25mm diameter ventilation holes covered with metal gauze must be provided in the floors or the boxes. Provisions must be made for clamping the cable to the bottom of the box. A 12mm steel stud welded to the outside bottom of the box must be provided for earthing of the cable.

3.2 OPTION 2:

The compound filling type must have easily accessible fill and drain openings. Tapered, tinned, combined brass wiping glands and earth connections must be provided. Compound complying with BS 1858 must be provided in separate tins.

B. MINISUBSTATIONS

1. STANDARDS

- 1.1 Mini substations shall comply with the requirements of SANS 1029, SANS 1030 and NRS 004-1 and shall be type B. Insulating oil shall conform to SANS 555.
- 1.2 Only mini substations manufactured from new material will be accepted. ***Refurbished transformers, ring-main units, or enclosures, will not be accepted.***

2. ENCLOSURE REQUIREMENTS

- 2.1 The substation enclosure shall consist of and comply with the following requirements:
 - 2.1.1 Manufactured of mild steel (hot dipped galvanized to SANS 763) or 3CR12 with a minimum thickness of 3mm. The **rating plate** must specifically indicate material as ***"mild 2,5mm steel – hot dipped galvanized to SANS 763" or "3CR12"***.
 - 2.1.2 Three separate compartments (i.e. MV, Transformer and LV). All fastening bolts and nuts shall be manufactured from brass or stainless steel.
 - 2.1.3 Removable roof with sufficient fastening bolts to withstand high winds.
 - 2.1.4 Ventilation openings for MV and LV compartments, placed and shielded such as to provide protection against the ingress of rodents, birds, snakes, insects, wire or other foreign objects and rain.
 - 2.1.5 Separate doors for MV and LV compartments. Doors shall be manufactured from mild steel (hot dipped galvanized to SANS 763) or from 3CR12 with a minimum thickness of 2,5mm and braced to obtain adequate rigidity.
 - 2.1.6 Door catches of the three point link locking mechanism type (Barker Nelson). The complete mechanism, including handles, shall be manufactured from ***stainless steel***. Handles shall be padlockable.
 - 2.1.7 Three heavy duty DEE type ***all stainless steel*** solid hinges for each door. The hinges, including fastening bolts and nuts, shall be manufactured from ***stainless steel***. Hinges shall measure not less than 60mm wide and not less than 6mm thick. Hinge pins shall be at least 10mm diameter.
 - 2.1.8 All doors shall be provided with suitable removable, ***non-corrosive*** restraints to prevent the doors from opening beyond 110 degrees. The restraints shall include a device to secure the door in the open position.
 - 2.1.9 Lifting lugs for the lifting and positioning of the substation by means of slings and cranes shall be provided.

3. MEDIUM VOLTAGE COMPARTMENT

- 3.1 The medium voltage compartment shall be fitted with a 3-phase 11kV ring main unit (RMU) in accordance with the following requirements:
- 3.1.1 SF6 insulated RMU Similar to Tamco GRI or ABB Safe Ring, SF6-filled ring-main unit.
The tenderer must specify the make and type offered.
- 3.2 The ring main unit shall contain : -
- 3.2.1. 2 - 11kV, 3-phase, ganged, manually operated, ring isolating switches with minimum rating of 20kA fault make and 400A load break.
- 3.2.2 1 – 11kV, 3-phase tee-off circuit breaker with a short-circuit making and breaking capacity of at least 20kA and minimum continuous current rating of 400A , to feed a distribution transformer in the adjacent minisub compartment which shall be protected against overcurrent and earth faults by means of automatic tripping of the RMU circuit breaker via suitable current transformers, time delay fuses and a protective relay built into each tee-off unit of the RMU, whose settings can be adjusted to accommodate a distribution transformer of either 500kVA or 800kVA. **11kV tee-off fuses will not be accepted.** Ring isolating switches and tee-off circuit breakers shall be quick-acting, spring-loaded for making and breaking and the operating mechanism shall be of the free handle type.
- 3.2.3 Integral earthing switches, safety interlocked, for ring cables and transformer tee-off. Electrical testing, such as pressure testing, of the 11kV cables connected to the RMU shall be possible by means of MV probes inserted into test sockets. A safety interlock mechanism shall ensure that access to the test sockets is denied until the cable has been earthed.
- 3.2.4 Mechanical indicators shall be provided for each switch or circuit breaker to show whether that particular circuit is “On”, “Off” or “earthed”.
- 3.2.5 An SF6 Gas pressure gauge shall be fitted which shall clearly show the safe working range in green and low pressure in red.
- 3.2.6 Each RMU shall be delivered complete with its first filling of SF6 gas at working pressure.
- 3.2.7 Blank labels, suitable for engraving, shall be affixed next to the controls for each of the 3 – 11kV circuits, and shall be clearly visible with the RMU compartment doors open.
- 3.2.8 The RMU shall be housed in a weatherproof and vermin proof enclosure, which shall be painted to withstand coastal conditions and the exterior finished in grey.
- 3.2.9 The RMU shall be self-contained and not require any external power-supply for its operation.
- 3.3 MV CABLE END BOXES
Cable end boxes must be suitable for the termination of 3 Core PILC 6.35/11kV cable up to 185mm², with optional compound filling or heat shrink boxes. To ease pricing in the bill of quantities, please offer all switchgear with heat shrink termination boxes and at the end of list of applicable items the additional charge for using compound filled boxes instead of heat shrink boxes. The description of the two types of cable end boxes are as follows:
- 3.3.1 OPTION 1:
The type used for heat shrink terminations must be fully enclosed with a removable lid. Four (4) 25mm diameter ventilation holes covered with metal gauze must be provided in the floors or the boxes. Provisions must be made for clamping the cable to the bottom of the box. A 12mm steel stud welded to the outside bottom of the box must be provided for earthing of the cable.
- 3.3.2 OPTION 2:
The compound filling type must have easily accessible fill and drain openings. Tapered, tinned, combined brass wiping glands and earth connections must be provided. Compound complying with BS 1858 must be provided in separate tins.

3.4 MV COMPARTMENT SHROUDING

The 11kV connections between the ring main unit and transformer shall be insulated and shrouded with solid barriers to provide protection against accidental contact, when the MV compartment doors are open.

4. TRANSFORMER COMPARTMENT

- 4.1 The design of the transformer tank shall allow for the exchanging and replacing of standard transformer units.
- 4.2 The transformer tank shall be hermetically sealed by means of welded lid;
- 4.3 The transformer shall be of the double-wound, three-phase, oil-immersed core type with **copper** windings arranged for natural oil cooling. **Aluminium windings will not be accepted.**
 - a. The first filling of oil is required.
 - b. The transformer shall comply with the following requirements: NRS 500 and SABS 780.
 - 4.5.1 Low loss type.
 - 4.5.2 11000/420 V
 - 4.5.3 Vector Group Dyn 11.
 - 4.5.4 The MV side shall be fitted with an off-load tap changer for voltage settings of 0; $\pm 2.5\%$ of nominal voltage. The tap-changer mechanism shall be pad lockable in each tap position.
 - 4.5.5 **The transformer shall carry the SABS mark together with the relevant specification number on the outside of the tank.**
- 4.6 The transformer compartment shall include the following equipment:
 - 4.6.1 Oil level indicator
 - 4.6.2 Porcelain bushings
- 4.7 An easily readable rating plate shall be provided in a suitable position on the outside of the transformer enclosure.

5. LOW VOLTAGE COMPARTMENT

5.1 BUSBARS

Bus bars shall have a minimum continuous current carrying capacity of 800 A for mini subs with a rating of up to 500kVA and 1200 A for mini subs with a rating of 800kVA. Bus bars shall be suitable for a 15 kA fault level enclosure.

A set of 4 identical, predrilled, tinned, copper bus bars shall be installed, complete with brass or stainless steel, bolts, washers and nuts;

5.2 MAIN SWITCH

A 25kA 400V 3-phase isolator, capable of breaking full rated load current, accessible from the front of the LV compartment, shall be provided between the transformer and the LV Bus bars to isolate the latter.

5.3 CONNECTIONS

- 5.3.1 Connections between bus bars, circuit breakers and transformers shall be of the colour-coded, PVC insulated, single core, stranded copper conductor type;
The conductor size between the transformer terminals and busbars shall be determined by the transformer rating. The following conductors shall be provided as standard for the various transformer ratings. The neutral conductor shall be the same size as the phase conductors;

200kVA:300A	400kVA: 600A	800kVA: 1200A
315kVA:450A	500kVA: 800A	

The minimum conductor rating between busbars and distribution circuit breakers shall be 300 A; Connections shall be done with suitable size lugs, complete with colour coded

heat shrink lug sleeves, bolted by means of stainless steel or brass bolts, nuts and lock washers.

- 5.3.2 All connections shall be electrically sound by first cleaning and then **applying a thin coating of Denso paste between mating faces before properly tightening.**

5.4 DISTRIBUTION CIRCUIT BREAKERS

CBI L20B (Previously Heinemann LY603) distribution circuit breakers shall be provided for the termination of solid aluminium conductor cables up to 185mm². The quantities and current ratings of distribution circuit breakers installed shall be as follows: -

5.5.2 Three dual Class 3 CT's.

- 5.5.3 One 96 mm x 96 mm 0 – 500 V indicating voltmeter with selector switch for the selection of 3 x phase to neutral and 3 x phase to phase voltages.

5.6 STREETLIGHTING CONTROL EQUIPMENT

The following streetlighting equipment shall be provided:

- 5.5.1 Main switch: 63A HRC fuse-switch complete with 63A cartridge fuses;
5.5.2 1 x 60A three pole, double break contactor with 230V coil to BSS 775;
5.5.3 1 x 1A, 5kA circuit breaker for photo-cell and contactor;
5.5.4 Three-position bypass switch for selection for the following modes:
 - Isolate streetlighting control equipment;
 - Photo-cell control;
 - Switch contactor on;

5.5.5 A three phase 80A kWh meter shall be installed to measure the total energy that is consumed by the streetlighting. The meter shall be similar to AMPI-kwh meter;

5.5.6 A photo-cell shall be provided as integral part of the mini substation. The photo-cell shall be installed at the back of the substation in a suitable, translucent enclosure for protection. The wiring between the photo-cell and control equipment shall be done with 1,5mm² PVC insulated conductors;

5.5.7 A minimum of 3 x 30A single pole, 5 kA streetlight supply circuit breakers shall be installed.

5.6 COVER PLATE

- 5.6.1 A steel cover plate (shroud plate) shall be fitted across the full width and height of the LV compartment to prevent inadvertent contact with live parts. The plate shall be ***hinged*** vertically and fastened with stainless steel screws to the minisub frame, when closed. The hinges shall be of stainless steel and of sufficient number and strength to carry the weight of the panel in the open position without sagging.
- 5.6.2 Circuit breaker toggles shall be operable and instrumentation faces shall be visible through suitable cut-outs in the cover panel when it is closed. Unused cut-outs shall be blanked off with steel blanking plates and screws.
- 5.7 **CABLE GLAND PLATES**
Individual cable gland plates, manufactured of 2 mm type 316 stainless steel, shall be provided without holes for cable glands or a DIN-rail complete with K-clamps as per specific order.
- 5.8 **EARTHING**
Brass or stainless steel earthing bolts shall be provided in the MV and LV compartments, complete with two brass or stainless steel washers, lock washer and nuts. Bolts shall be 12mm diameter; a copper earth bar (with 13mm predrilled holes) shall be installed in the LV compartment. The earth bar shall have a minimum cross sectional area of 80mm² and minimum length of 120 mm. Standard copper earth conductors with a minimum cross sectional area of 63 mm² shall be provided between compartments, earth bolts, neutral bar and earth bar.
- 5.9 **TREATMENT AND FINISH**
The substation enclosure complete with all metal parts shall be hot dip galvanized in accordance with the requirements of SANS 763, where 3CR12 is not used;
The transformer LV compartment including the cover plates, shall be hot dip galvanized or zinc sprayed; the final zinc layer of the hot metal spray coating shall be 20% thicker than the specified thickness of the hot dip galvanizing process;

Paint finish:

Primer: Calcium Plumbate (24 hours drying)

1st Coat: Chlorinated Rubber

2nd Coat: Chlorinated Rubber

The colour of the enclosure shall be C12 "Avocado" in accordance with SANS 1091;

The colour of the cover plate and frame of the LV compartments shall be white.

ALL PAINT FINISHES SHALL BE GUARANTEED FOR 24 MONTHS AGAINST FLAKING OR PEELING

5.10 **NOTICES AND LABELS**

- 5.10.1 **Identification Signs:** External and Internal identification labels shall, where specified with the order, comply with Municipal Drawing No. GEN-10 in respect of material, label size, colour, size of lettering and mounting holes. Fastening shall be by means of 5mm stainless steel or brass machine screws and nuts.
- 5.10.2 **Danger signs:** Non-corrosive, SABS approved electrical high voltage danger signs shall be fitted by means of non-corrosive pop rivets to the door of MV and LV compartments;
- 5.10.3 **LV compartment labels:** The following equipment in the LV compartment shall be labeled. Labels shall be white Celeron with black lettering, fastened with brass or stainless steel screws. Glued labels shall not be accepted:

General Conditions of Contract

1. **Definitions:**
1. The following terms shall be interpreted as indicated:
 - 1.1 “Closing time” means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 “Contract” means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 “Contract price” means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
 - 1.4 “Corrupt practice” means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 “Countervailing duties” are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 “Country of origin” means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 “Day” means calendar day.
 - 1.8 “Delivery” means delivery in compliance of the conditions of the contract or order.
 - 1.9 “Delivery ex stock” means immediate delivery directly from stock actually on hand.
 - 1.10 “Delivery into consignees store or to his site” means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the goods are so delivered and a valid receipt is obtained.
 - 1.11 “Dumping” occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
 - 1.12 “Force majeure” means an event beyond the control of the supplier and not involving the supplier’s fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
 - 1.13 “Fraudulent practice” means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
 - 1.14 “GCC” means the General Conditions of Contract.
 - 1.15 “Goods” means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
 - 1.16 “Imported content” means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs

such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the goods covered by the bid will be manufactured.

- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25 "Supplier" means the successful bidder who is awarded the contract to maintain and administer the required and specified service(s) to the State.
- 1.26 "Tort" means in breach of contract.
- 1.27 "Turnkey" means a procurement process where one service provider assumes total responsibility for all aspects of the project and delivers the full end product / service required by the contract.
- 1.28 "Written" or "in writing" means hand-written in ink or any form of electronic or mechanical writing.

2. Application:

- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services (excluding professional services related to the building and construction industry), sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General:

- 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2 Invitations to bid are usually published in locally distributed news media and on the municipality/municipal entity website.

4. Standards:

- 4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

5. Use of contract documents and information inspection:

- 5.1 The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the provider in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
- 5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the provider's performance under the contract if so required by the purchaser.
- 5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.
6. Patent rights:
 - 6.1 The provider shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.
 - 6.2 When a supplier developed documentation / projects for the municipality or municipal entity, the intellectual, copy and patent rights or ownership of such documents or projects will vest in the municipality or municipal entity.
7. Performance security:
 - 7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
 - 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
 - 7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
 - (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
 - (b) a cashier's or certified cheque.
 - 7.4 The performance security will be discharged by the purchaser and returned to the provider not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified.
8. Inspections, tests and analyses:
 - 8.1 All pre-bidding testing will be for the account of the bidder.
 - 8.2 If it is a bid condition that goods to be produced or services to be rendered should at any stage be subject to inspections, test and analyses, the bidder or contractor's premises shall be open, at all reasonable hours, for inspection by

- a representative of the purchaser or an organization acting on behalf of the purchaser.
- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the goods to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5 Where the goods or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such goods or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Goods and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7 Any contract goods may on or after delivery be inspected, tested or analysed and may be rejected if found not to comply with the requirements of the contract. Such rejected goods shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with goods which do comply with the requirements of the contract. Failing such removal the rejected goods shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute goods forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected goods, purchase such goods as may be necessary at the expense of the supplier.
- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.
9. Packing:
- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, and in any subsequent instructions ordered by the purchaser.
10. Delivery and documents:
- 10.1 Delivery of the goods and arrangements for shipping and clearance obligations shall be made by the supplier in accordance with the terms specified in the contract.
11. Insurance:
- 11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified.

12. Transportation:

- 12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified.

13. Incidental services:

- 13.1 The supplier may be required to provide any or all of the following services, including additional services, if any:

- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
- (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
- (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
- (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

- 13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the provider for similar services.

14. Spare parts:

- 14.1 As specified, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
- (b) in the event of termination of production of the spare parts:
 - (i) advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty:

- 15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

- 15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise.
- 15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
- 15.4 Upon receipt of such notice, the supplier shall, within the period specified and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
- 15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

16. Payment:

- 16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified.
- 16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfillment of other obligations stipulated in the contract.
- 16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
- 16.4 Payment will be made in Rand unless otherwise stipulated.

17. Prices:

- 17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the provider in his bid, with the exception of any price adjustments authorized or in the purchaser's request for bid validity extension, as the case may be.

18. Variation orders:

- 18.1 In cases where the estimated value of the envisaged changes in purchase does not exceed 15% of the total value of the original contract, the contractor may be instructed to deliver the goods or render the services as such. In cases of measurable quantities, the contractor may be approached to reduce the unit price, and such offers may be accepted provided that there is no escalation in price.

19. Assignment:

- 19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

20. Subcontracts:

- 20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under these contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

21. Delays in the Supplier's Performance:

- 21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.3 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the goods are required, or the supplier's services are not readily available.
- 21.4 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 22.2 without the application of penalties.
- 21.5 Upon any delay beyond the delivery period in the case of a goods contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.
22. Penalties:
- 22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.
23. Termination for default:
- 23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
 - (b) if the supplier fails to perform any other obligation(s) under the contract; or
 - (c) if the supplier, in the judgement of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems

- appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
- 23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
- 23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the supplier as having no objection and proceed with the restriction.
- 23.5 Any restriction imposed on any person by the purchaser will, at the discretion of the purchaser, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the purchaser actively associated.
- 23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:
- (i) the name and address of the supplier and / or person restricted by the purchaser;
 - (ii) the date of commencement of the restriction;
 - (iii) the period of restriction; and
 - (iv) the reasons for the restriction.
- These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.
- 23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.
24. Anti-Dumping and Counter-Vailing duties and rights:
- 24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the supplier to the purchaser or the purchaser may deduct such amounts from moneys (if any) which may otherwise be due to the supplier in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.

25. Force Majeure:

- 25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

26. Termination for insolvency:

- 26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

27. Settlement of disputes:

- 27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4 Notwithstanding any reference to mediation and/or court proceedings herein,
(a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
(b) the purchaser shall pay the supplier any monies due to the supplier for goods delivered and / or services rendered according to the prescripts of the contract.

28. Limitation of liability:

- 28.1 Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;
(a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and
(b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

29. Governing language:
- 29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.
30. Applicable law:
- 30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified.
31. Notices:
- 31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.
- 31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.
32. Taxes and duties:
- 32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid SARS must have certified that the tax matters of the preferred bidder are in order.
- 32.4 No contract shall be concluded with any bidder whose municipal rates and taxes and municipal services charges are in arrears.
33. Transfer of contracts:
- 33.1 The contractor shall not abandon, transfer, cede assign or sublet a contract or part thereof without the written permission of the purchaser.
34. Amendment of contracts:
- 34.1 No agreement to amend or vary a contract or order or the conditions, stipulations or provisions thereof shall be valid and of any force unless such agreement to amend or vary is entered into in writing and signed by the contracting parties. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.
35. Prohibition of restrictive practices:
- 35.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder(s) is / are or a contractor(s) was / were involved in collusive bidding.
- 35.2 If a bidder(s) or contractor(s) based on reasonable grounds or evidence obtained by the purchaser has / have engaged in the restrictive practice

referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties are contemplated in section 59 of the Competition Act No 89 of 1998.

- 35.3 If a bidder(s) or contractor(s) has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.
