SECTION 2

SPECIAL INSTRUCTIONS AND CONDITIONS OF THE RFQ

1. Under no circumstances whatsoever may the bid/RFQ forms be retyped or redrafted.
2. The bidder is advised to check the number of pages and to satisfy themselves that none are missing or duplicated.
3. Bids/Proposals submitted must be complete in all aspects of the bid. Bids/Proposals will only be considered if correctly completed and accompanied by all relevant and /or necessary applicable information.
4. Bids/Proposals shall be lodged at the address or e-mailed not later than the closing date and time specified and in accordance with the directives in the bid documents.
5. Use of correcting fluid or erasable pencil is prohibited.
6. NNR reserves the right to reject all responses submitted by bidders and to embark on a new bid/RFQ process.
7. A Service Level Agreement will be signed with the successfully bidder.
8. The NNR at its own discretion may vary the scope of this bid/RFQ to include or exclude more scope/work. In the case of the latter the bidder will not be entitled to claim for work not required.
9. Commencement of work shall be subject to receipt of an official purchase order and conclusion of the Service Level Agreement (where applicable).
10. The NNR will only commence the payment process after receipt of a bill of costs and/or invoice from the bidder and after such has been approved by the client division as representing the services rendered for the project.
11. Payments of invoices will be settled within 30 days from receipt of a correct and original invoice. **No upfront payments will be made; the successful bidder will only be paid after the services have been rendered.** All payments will be made by the NNR ONLY through electronic bank transfer into a banking account of the successful bidder.

12. The NNR will not be liable for any expenses incurred by the bidder(s) during the bidding process.

13. Under no circumstance will the NNR return proposals received and /or submitted in any format. These proposals shall be kept confidential for internal consideration.

14. The NNR reserves the right to:

15.1 To amend any bid/RFQ conditions, specifications, terms of reference, extend the validity period or extend the closing date of the bid/RFQ.

15.2 Not to accept the lowest bid or any bid part or in whole. The NNR may award the bid to the bidder who proves to be capable of handling the services and whose bid is technically acceptable and/or financially advantageous to the NNR.

14.3 To award this bid as a whole or in part without furnishing reasons.

14.4 To extend/decrease the scope of work relating to this bid/RFQ to include any of its affiliates if required. The implication of the scope changes (if any) will be subject to negotiations between the NNR and the successful bidder.

14.5 To cancel and/or terminate the bid/RFQ process at any stage, including after the closing date and/or after presentations have been made, and/or after bids have been evaluated and/or after shortlisted bidders have been notified of their status.

14.6 To conduct site inspections and or due diligence, or explanatory meetings in order to verify the nature and quality of services offered by the bidder. This will be done before/or after adjudication of the bid. The site inspection and or due diligence will be carried out with shortlisted bidders only. (where applicable)

14.7 The NNR may request written clarification or further information regarding any aspect of the proposal. The bidder/s must supply the requested information in writing within two (2) working days after the request has been made, otherwise the proposal may be disqualified.

14.8 To contact references to obtain information (where applicable).

- 14.9 Should the parties at any time before and/or after the award of the bid/RFQ and prior to, and /or after issuing an appointment letter or purchase order fail to agree on any significant service, price, change in terms of reference or change in services etc., the NNR shall be entitled to recall the letter of appointment or purchase order and cancel the award by giving the bidder a written notice of such.
- 14.10 Negotiate rates submitted by bidders.
- 14.11 Such cancellation shall mean that the NNR reserves the right to award the same proposal to the next best bidder as it deems fit.
- 14.12 The successful bidder must ensure that all personnel working under this contract are suitably experienced prior to the commencement of services and remain in the project for the duration of the contract.
- 14.13 The General Conditions of Contract will apply to this bid.

2. IMPROPER ASSISTANCE, FRAUD AND CORRUPTION

- 2.1 The NNR reserves the right to disqualify any bidder who;
- 2.1.1 engages in any collusive tendering, anti-competitive conduct, or any other similar conduct, including but not limited to any collusion with any other bidder or company / business in respect of the subject matter of this bid/RFQ;
- 2.1.2 Bidders who seek or obtain the assistance from employees, contractors, or advisors of the NNR in the preparation of their responses.
- 2.1.3 Bidders must familiarise themselves with the implications of contravening the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004 and any other relevant legislation.

3. NOTICE TO BIDDERS

- 3.1 The NNR calls on all service providers/ bidders not to be lured into tender (bid) fraud scam which requires upfront payment in doing business with the NNR.

Non-Restricted

- 3.2 The NNR would like to clearly state that service providers/bidders are not expected to pay any fee upfront to be awarded a tender (bid).
- 3.3 Service providers / bidders are urged to remain vigilant to the tender (bid) scam and any other scams. On suspicions of such, service providers/ bidders are advised to report it to law enforcement agencies and /or the NNR SCM or Legal Services officials.

4. UNDERTAKING AND OBLIGATION OF THE BIDDER

- 4.1 The successful bidder may, upon receipt of written notification of an award, be required to conclude a Service Level Agreement (SLA) with the NNR, which will form an integral part of the service provider's agreement. The SLA will serve as a tool to measure, monitor and assess the service provider's performance level and ensure effective delivery of service, quality and value-add business for the NNR.
- 4.2 The successful bidder shall render all or any of the services described in the attached documents on NNR terms and conditions and in accordance with the terms of reference stipulated in the bid document (which shall be taken as part of, and incorporated into bid proposal)
- 4.3 The bidder shall prepare possible presentation should the NNR require such and the bidder shall be notified thereof in time before the actual presentation date.
- 4.4 The bidder hereby agrees that the offer herein shall remain binding upon receipt of acceptance by the NNR during the validity period indicated and calculated from the closing date of the bid; this offer and its acceptance shall be subject to the terms and conditions in this bid document.
- 4.5 The bidder shall confirm their satisfaction to the correctness and validity of the bid response that the price/s quoted cover all the work/items(s) specified in the bid response document and that the price(s) cover all obligations under a resulting contract and he/she accept that any mistake regarding price(s) and calculations will be at their own risk.
- 4.6 The bidder accepts full responsibility for the proper execution and fulfillment of all obligations and conditions arising under this agreement as the main fulfillment liable due to this contract.

5. LEGISLATIVE FRAMEWORK OF THE BID

5.1 Tax Legislation

- 5.1.1 Bidder(s) must be compliant when submitting a proposal to the National Nuclear Regulator and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).
- 5.1.2 It is a condition of this bid that the tax matters of the successful bidder are in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations.
- 5.1.3 The Tax Compliance status requirements are also applicable to foreign bidders / individuals who wish to submit bids.
- 5.1.4 It is a requirement that bidders grant a written confirmation when submitting this bid that SARS may on an on-going basis during the tenure of the contract disclose the bidder's tax compliance status and by submitting this bid such confirmation is deemed to have been granted.
- 5.1.5 Bidders are required to be registered on the Central Supplier Database and the National Treasury shall verify the bidder's tax compliance status through the Central Supplier Database.
- 5.1.6 Where Consortia / Joint Ventures / Sub-contractors are involved, each party must be registered on the Central Supplier Database and their tax compliance status will be verified through the Central Supplier Database.
- 5.1.7 Bids received from bidders with a non-compliant tax status may be disqualified with failure to update the Tax Status within 7 days.

5.3 Technical Legislation and/or Standards

- 5.3.1 Bidder(s) should be cognisant of the legislation and/or standards specifically applicable to the services.

6. COUNTER CONDITIONS

The Bidder's attention is drawn to the fact that amendments to any of the Bid Conditions or setting of counter conditions by Bidders or qualifying any Bid Conditions will result in the invalidation of such bids.

7. COMPANY VETTING

The successful bidder(s) may be subjected to a security screening /or vetting process by the State Security Agency at any stage during the contract. If the results thereof are negative and/or unfavourable and/or have a material or adverse effect to the carrying out of the contract, the NNR shall be entitled to immediately cancel the contract in writing

SECTION 4: TECHNICAL SPECIFICATIONS

1. INTRODUCTION

- 1.1 The National Nuclear Regulator (NNR) is a public entity which is established and governed in terms of Section 3 of the National Nuclear Regulator Act, (Act No 47 of 1999) to provide for the protection of persons, property, and the environment against nuclear damage through the establishment of safety standards and regulatory practices.

2. PURPOSE

- 2.1 The purpose of the bid is for the appointment of a service provider that will provide a comprehensive and flexible asset management software solution. That will allow NNR users to create, maintain, track, account, and report on their capital assets.

3. BACKGROUND

- 3.1. The NNR is currently using an assets system and its verification system with the scanners. The NNR seeks to appoint a service provider to provide software solution, support, and maintenance on the Assets Management and verification system compatible to assetware manager for a period of four (4) years.

THE NNR REQUIRES AN ASSETS MANAGEMENT AND VERIFICATION SYSTEM AS FOLLOWS:

- 3.2 The NNR uses GRAP accounting standard and requires a system that fully supports GRAP accounting practices and process requirements.

Non-Restricted

3.3 The NNR uses the following On-Prem IT infrastructure environment to host the current system and its applications:

- Server type: the server is hosted on a Dell server.
- Server operating systems: Windows Server 2022 Standard, 64bit
- Database Versions: Microsoft SQL Server 2022

3.4 The NNR requires a comprehensive Assets Management system (Asset ware) that is able to perform but not limited to the following functions:

- Capture detailed asset information and transaction events.
- Capture Multiple invoices per asset record. Invoices are recorded against the asset and identified as capital, expense, or improvements. This also includes credit notes.
- Apply number of depreciation standard methods and user defined options.
- Record Current Cost Accounting transaction.
- Perform bulk operations for additions, transfers, disposals, asset re-life's and more, allow easy bulk import of transactions.
- Apportion depreciation charges across multiple departments and cost centres.
- Upload Image and document for each asset record.
- Perform full asset disposals and transfers transactions.
- Integration to SAGE 300 ERP, and Verification system.
- Export of assets register, depreciation report, additions, disposal and other related reports provide system views based upon the company structures, user defined views, allow for assets and reports to be easily filtered.
- Allow full report customisation, from the system data.
- Directly export to numerous file formats including Excel, PDF and HTML
- Provide past, current, and future reporting options.
- Provide the standard financial reports required including Statutory, reconciliation summary and Journals.
- Check In/Check Out
- Full Lifestyle History
- QR Code Generation
- Reporting Access
- Custom Report
- Asset Listing View
- Real-Time Notification

3.5 The NNR also requires an assets verification system with a handheld scanner compatible to the latest technology that can perform but not limited to the following functions:

- Scan and link asset barcode to the register.
- Update assets details on the register such as location, custodian, condition and other.
- Capture new assets identified during the asset's verification.
- Integrate the verification data to the assets management system. (Asset ware)
- Update assets description.
- Export assets verification information to file formats including Excel, PDF and HTML.
- Export individual inventory sheet.
- Provide real time update of the register on the assets management system. (Asset ware)
- Capture and preview assets image,
- Track asset's location.

1. MAINTENANCE SERVICE

4.1 In order for the NNR's Assets Accounting system, verification system and/or scanners to continue functioning effectively and optimally, the appointed service provider will be required to provide the following maintenance services:

- Migration and import of the assets register from the current system to the new system.
- Facilitation of license renewals to ensure that the NNR operates on the updated and verified licenses.
- Recommend new products or add-on modules to the system to ensure that the NNR is functioning effectively and efficiently.
- Installing software upgrades and security patches for the system and other systems versions as and when available in consultation with NNR and/or NNR system administrator and applications officer.
- Modifications of the Assets accounting system, Scanners and any offered system where errors occur during operational processing, diagnostics are performed, and errors are resolved by fixing the program code ("bug" fixes).
- Assets accounting system database check-ups and testing.

Non-Restricted

- 1.2 The service provider will be required to provide the software maintenance services to ensure adequate asset system for the NNR.
- 1.3 The service provider will be required to provide skills transfer on maintenance to the NNR system administrator and Applications Officer

2. SUPPORT SERVICE

- 5.1 The NNR requires functional, technical and troubleshooting support services for the Assets Accounting system, Scanners, any related systems environment and integration applications:
 - 5.1.1 Providing a telephonic, onsite, remote and e-mail support service throughout the maintenance and support period.
 - 5.1.2 The turnaround time for incident resolution will be defined through an agreed SLA between the NNR and the appointed service provider.
 - 5.1.3 Providing on-site visits for major issues, which need to be resolved in person.
 - 5.1.4 Training of users and application administrators (support services for all asset management system) as required.
 - 5.1.5 Provide update and revision of End User Manuals based on the system changes and provide System change request to the NNR System administrator.
 - 5.1.6 Provide an option for support service through use of prepaid hours.

REQUIREMENTS

SECTION 5: EVALUATION AND SELECTION PROCESS

1. EVALUATION PROCESS

1.1 The Bid will be evaluated in four phases as follows:

1.1.1 Phase 1: Administrative Compliance

Administrative criteria will be applied in the initial stage of the evaluation. Bidders who do not meet all the administrative compliance criteria may not be considered for Phase 2 of the evaluation.

1.1.2 Phase 2: Functional Evaluation Criteria

The evaluation criteria aim to assess the bidder's capability, reliability, and ability to execute and maintain a bid and / or contract. Bids will be evaluated according to the bid evaluation criteria stipulated in the terms of reference. Bids that fail to meet the minimum qualifying score will be disqualified.

1.1.3 Phase 3 – Specific Goals and Price

In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the specific goals prescribed and must be supported by proof/ documentation stated in the conditions of this tender.

The Bidders which have passed the initial and first stages of the bidding process will be scored on the basis of price and specific goals allocation in accordance with the applicable legislation.

The successful Bidder will typically be the Bidder that scores the highest number of points on Phase 4 of the Bid evaluation, unless the NNR exercises its right to cancel the tender or there is an objective criteria to justify awarding a contract to another bidder that did not obtain the highest score.

1.2 PHASE 1: Administrative Compliance

1.2.1 The following administrative compliance will be applied in the initial stage of the evaluation. **Bidders who do not meet and/or submit the administrative compliance may not be considered for price and specific goals.**

1.2.2 Bidders are required to complete the table below by indicating whether they comply with the requirement by marking the appropriate column with an 'X' on the table below. Bidders are required to corroborate each requirement, where applicable.

1.3 PHASE 2: Functional Evaluation Criteria

- a. Bids will be evaluated according to the bid evaluation criteria stipulated in the terms of reference.
- b. Bidders must, as part of their bid documents, submit supportive documentation for all technical requirements as indicated hereunder. The committee responsible for scoring the respective bids will evaluate and score all bids based on the submissions and the information provided.
- c. Bidders will not rate themselves, but need to ensure that all information is supplied as required.
- d. The Bid Evaluation Committee (BEC) will evaluate and score all responsive bids and will verify all documents submitted by the bidders.
- e. The committee will individually evaluate the responses received against the following criteria as set out below: each individual criterion on the score sheet using the following scale of **0-5** in accordance with the criteria below. The rating will be as follows; 0= very poor, 1=poor; 2= Average; 3= Good; 4= Very Good and 5= Excellent.

Total points scored by bidder for functionality= Weighted value score

Percentage allocated for functionality (100)

- f. Individual value scores will be multiplied with the specified weighting for the criterion to obtain the marks scored for all elements. These marks will be added and expressed as a fraction of the best possible score for all criteria.
- g. Only bidders that have met or exceeded the minimum threshold of **65** out of 100 for functionality will be considered for the next phase(Demo presentation)
- h. Any proposal not meeting a minimum score of 65 for functionality proposal will be disqualified, and will not be evaluated further on Price and Specific Goals

1.5 PHASE 4: Price and Specific Goals

1.5.1 In terms of Regulation of the preferential Procurement Regulations pertaining to the Preferential Procurement Framework Act, 2000 (Act 5 of 2000) responsive bids will be evaluated on the **80/20**-point system in terms of which points are awarded to bidders based on:

- Price points **80**
- Specific goals **20**

1.5.1.1 Price points

The following formula will be used to calculate the points for price:

1.5.1.2 Specific goals

A maximum of 20 points may be awarded in respect of specific goals, which points must be awarded to a bidder for attaining the specific goals in accordance with the table below:

- 1. Definitions**
- 1 The following terms shall be interpreted as indicated:
- 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day
- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
- 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.

The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination. |

- 15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
- 15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
- 15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.
- 16. Payment**
- 16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC.
- 16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract.
- 16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
- 16.4 Payment will be made in Rand unless otherwise stipulated in SCC
- 17. Prices**
- 17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.
- 18. Contract amendments**
- 18.1 No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.
- 19. Assignment**
- 19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.
- 20. Subcontracts**
- 20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under this contract if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.
- 21. Delays in the supplier's performance**
- 21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.3 No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.
- 21.4 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an

emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.

21.5 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.

21.6 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. Termination for default

23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part.

- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
- (b) if the Supplier fails to perform any other obligation(s) under the contract; or
- (c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the

- purchaser may regard the intended penalty as not objected against and may impose it on the supplier.
- 23.5 Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.
- 23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:
- (i) the name and address of the supplier and / or person restricted by the purchaser;
 - (ii) the date of commencement of the restriction
 - (iii) the period of restriction; and
 - (iv) the reasons for the restriction.
- These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.
- 23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.
- 24. Anti-dumping and countervailing duties and rights** 24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.
- 25. Force Majeure** 25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof.
