South African National Parks invites tenders for **Renovations of 10 Chalets in Main Camp at the Addo Elephant National Park, Eastern Cape**

SANParks invites prospective bidders for the Renovation of 10 chalets at Main Rest Camp in Addo Elephant National Park.

The following tenderers who are registered with the CIDB, or are capable of being so registered prior to the evaluation of submissions are eligible to submit tenders:

- Contractor grading designation equal to or higher than a contractor designation grading designation determined in accordance with the sum tendered, or a value determined in accordance with Regulation 25 (1B) or 25 (7A) of the Construction Industry Development Regulations, for a **4 GB (or 3GBPE)** or higher-class construction work, are eligible to have their tenders evaluated.

Tender documents will only be available on the **27 July 2023** at the compulsory site clarification meeting. The site and tender clarification meeting is **COMPULSORY**.

The tender document is issued at a non-refundable fee of **R300.00 cash only**.

The clarification meeting with representatives of the Employer will take place **The Interpretive Centre** in the **Addo Main Camp, Addo Elephant National Park, Eastern Cape** on **27 July 2023 at 11h00**.

The Tenderers shall inspect and examine the Site and its surroundings and shall satisfy themselves before submitting their tender as to the form and nature of the Site, the quantities and nature of the work and materials necessary for the completion of the Works and the means of access of the Site, the accommodation they may require and in general shall themselves obtain all necessary information as to risk, contingencies and other circumstances which may influence or affect their tender.

The tenderers must be represented at the site inspection by a person who is suitably qualified and experienced to comprehend the implications of the work involved. Attendance of the site inspection is compulsory and a tender will be disqualified if the site inspection is not attended

by a representative of the tenderer.
