1. PURPOSE

The purpose of this RFQ is to invite a supplier to submit formal written quotation for the cutting of grass, landscaping, and removal of garden refuse at West Coast National Park.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

SANParks needs to appoint a company to provide a service for cutting of grass, landscaping and removal of garden refuse at the SANPARKS Admin Office in Langebaan, Geelbek Precinct and West Coast National Park tourism accommodation. All garden refuse to be removed from site during cleaning/clearing and to be put in refuse bags to be transported out of the national park.

Hours of operation for cleaning and removal of vegetation must be scheduled between 08H00 and 15H30 Monday to Friday only. All SANParks rules and regulations will apply for the contractor during the cleaning operation. All workers must comply to HOS standards. (PPE) Inspection will be done by SANParks officials daily.

3.1 DESCRIPTION OF SERVICE

- **Cutting of grass**
- **Landscaping (e.g., pruning trees, brush cut rough areas, re-vamping entrance gates etc.)**
- **Removal and disposal of all Garden Refuse**
- **Only 12 Services will be required per month for 12 Months**

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
