- 1.1.1. The Safety and Security Sector Education and Training Authority (SASSETA) is one of the twenty-one Sector Education and Training Authorities (SETAs) established in terms of the Skills Development Act (Act 97 of 1998) as amended. SASSETA's licence has been renewed until 31st March 2030.

1.2. PURPOSE

- 1.2.1. The purpose of this RFQ is to appoint a suitable service provider to supply, deliver, install, support and provide maintenance on the ICT Peripherals on an ad hoc basis from the date of appointment until 31 March 2030 at two (2) KZN regional offices.

1.4. **TIMEFRAMES FOR DELIVERY OF THE WORK**

- 1.4.1. This contract will commence from the date of appointment until 31 March 2030.
- 1.4.2. The service provider is required to deliver the ordered tools within 14 working days from the date of the order.

1.5. **SUBMISSION REQUIREMENTS**

- 1.5.1. The bidding company to submit one (1) Reference letter demonstrating that the service providers previously delivered and maintained ICT Peripherals.

- 1.5.2. The bidding company to submit CV of the technician/specialist demonstrating a minimum of one (1) assignment in delivering, configuring, support and maintenance of UPS.

1.6. PRICING

- 1.6.1. Service Providers are requested to provide an unit costs for all items on SBD 3.1. Items are to be quoted on unit costs and SASSETA will order varying quantities on an ad hoc basis, as and when the items are required.
- 1.6.2. Where the contract requires the successful bidder to travel to a venue different from SASSETA, the following travel and disbursement processes will be undertaken:
 - 1.6.2.1. Claim travel mileage costs applicable to this contract as per the Department of Transport rates.
 - 1.6.2.2. Book only economy-class flights
 - 1.6.2.3. Book Group A hire cars, otherwise, Group B is to be used for Service Providers outside of Gauteng.
 - 1.6.2.4. Utilise cost-effective modes of transport such as Uber/Taxify/Gautrain or shuttle services when traveling to and from the airport.
 - 1.6.2.5. Book only Bed and Breakfast, Hotels, or other equivalent accommodations up to a Rand value of R1 400/ three (3) Star per night per person (including dinner, breakfast, and parking).
 - 1.6.2.6. Submit all applicable invoices/receipts for the travel undertaken and a Google map of the trip where travel by private car was undertaken for payment.
 - 1.6.2.7. All travel is to be approved by SASSETA before being undertaken.

- 1.9.1. The service provider will be contracting with SASSETA. To this end, the service provider will be required to sign a confidentiality agreement within the Contract.
