1. INTRODUCTION

The Media, Information and Communication Technologies Sector Education and Training Authority ("MICT SETA") is established in terms of section 9(1) of the Skills Development Act, 1998 (Act No. 97 of 1998), and is responsible for achieving South Africa's skills development and economic growth within the following five sub-sectors: advertising, film and electronic media, electronics, information technology and telecommunications.

2. SCOPE OF WORK

The ETQA is delegated as Quality Partner by the QCTO by means of an SLA. 8. EVALUATION CRITERIA

MICT SETA complies with the provisions of the Public Finance Management Act, Act No. 1 of 1999 as amended; Treasury Regulations of 2005; the Preferential Procurement Policy Framework Act, Act No. 5 of 2000; Preferential Procurement Regulations of 2022; and the MICT SETA Supply Chain Management (SCM) Policy.

RFQs received will be evaluated on mandatory evaluation and price and specific goals.

8.1. STAGE 1: MANDATORY CRITERIA

8.1.1. Experience of the Project Team

The bidder must have a Project Lead Consultant (PLC) clearly indicated in the submission. The PLC must have a minimum of two (2) years' experience in occupational programme (skills programme or full/part qualifications) development or qualification realignment

Proof of evidence to criteria

The bidder must submit the detailed CV of the proposed Project Lead Consultant (PLC), clearly marked as such, demonstrating a minimum of two (2) years' experience in occupational programme (skills programmes and/or full or part qualifications) development or qualification realignment, including periods of engagement, roles performed, and relevant projects undertaken.

8.1.2. SAQA Qualification development / realignment

The Bidder/Project Lead Consultant must have successfully developed / realigned programmes in line with SAQA requirements.

Proof of evidence to criteria

Bidders must provide evidence of at least two (2) registered and/or approved occupational programmes, including full qualifications, part-qualifications, or skills programmes, that were successfully developed by the Bidder and/or the Project Lead Consultant.

Bidders must have past experience in the development of occupational programmes conducted from different clients within the Republic of South Africa. Reference letters from other SETAs outside of the MICT SETA are preferable.

Bidders must provide two (02) signed contactable reference letters from different clients indicating experience in conducting the development of occupational programmes within the Republic of South Africa aligned with documents of occupational programmes submitted.

Reference letters must be on company letterhead, signed by company representative of the bidder's / PLC client. Contactable references must include name of company, contact details, and project description, the scope of work should have been completed in the last five (05) years.

9. STAGE 2 PRICE AND SPECIFIC GOALS

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to
