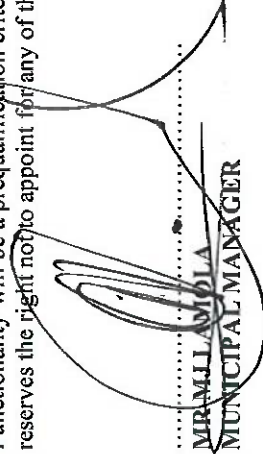
A maximum of twenty (20) point must be awarded to a bid of an HDI person/s in terms of the Act mentioned above and the Council's Supply Chain Management Policy.

The 90/10 preference system (from R50 000 000 - upwards).

A maximum of 10(ten) points must be awarded to a bid of an HDI person/s in terms of the Council's Supply Chain Management Policy.

The local HDI will be allocated extra points in terms of the Council's Supply Chain Management Policy.

Functionality will be a prequalification criterion to these bids where applicable. All bids submitted shall be valid for 90 days after the closing date. Lekwa Local Municipality reserves the right not to appoint for any of these bids.
