Dube TradePort Corporation (DTPC) wishes to appoint a company with a minimum CIDB grading of 5GB/CE or higher plus a demonstrable strong engineering implementation experience and have an ability to undertake a multi-disciplinary project which includes supply, delivery, installation and commissioning of bulk water infrastructure, greenhouse tunnels, and associated infrastructure.

Local Production and content requirement:

- a) In line with the National Treasury Instruction notes, this bid has a Local Production and Content for designated sectors as follows:
 - a. Steel must be 100%,
 - b. pipes must be 100%,
 - c. electrical cables must be 65%

It is a bidding condition that all bidders must meet the local production and content requirement. A bidder that does not meet this requirement will **not** be eligible to tender as their bid proposal will **not** be acceptable.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance assessment, functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2017 using the 80/20 preference points system.
