STANDARD CONDITIONS OF TENDER (Goods / Services)

1. DEFINITIONS

General:

- (1) Defined words / phrases are printed in *Italic font*.
- (2) Definitions apply to the singular as well as the plural.
- (3) Any reference to the masculine gender shall be taken to include the feminine and any reference to the feminine gender shall be taken to include the masculine.
- (4) The words “bid” and “tender”, and “bidder” and “tenderer” can be used interchangeably.
- (5) All definitions as defined in the ***General Conditions of Contract*** are applicable to these ***Standard Conditions of Tender***. These definitions include:

 - “Contract”
 - “Contract Price”
 - “Corrupt practice”

- (6) **Bid or Tender:** The offer submitted in respect of an invitation to submit such an offer.
- (7) **Bidder or Tenderer:** An entity (company, close corporation, partnership, joint venture, sole proprietor) which submits a *bid/tender*.
- (8) **Municipality:** The eThekweni Municipality, as represented by the duly authorised delegate, official or committee.
- (9) **SCT:** Special Conditions of Tender (found in Section 3).
- (10) **Week:** A period of seven (7) consecutive *days*.
- (11) **Material Deviation:** A material deviation or qualification is one which, in the *Municipality’s* opinion, would:
 - (a) Detrimentially affect the scope, quality, or performance of the services or supply identified in the Scope;
 - (b) Significantly change the *Municipality’s* or the *Tenderer’s* risks and responsibilities under the contract; or
 - (c) Affect the competitive position of other *Tenderers* presenting responsive *tenders*, if it were to be rectified.

2. CONDITIONS OF TENDER & CONTRACT

The specification will be governed by the ***Standard Conditions of Tender*** (Goods and Services), ***Special Conditions of Tender (SCT)***, ***General Conditions of Contract (GCC)*** (Government Procurement General Conditions (July 2010), as amended by National Treasury Circular 52 dated 30 July 2010), the ***Special Conditions of Contract (SCC)***, the ***Occupational Health and Safety Act*** (Act No. 85 of 1993), and the ***eThekweni Code of Conduct***.

Complete Acceptance of Conditions

Unless otherwise expressly stipulated in a letter covering the *tender*, every *Tenderer* shall be deemed to have waived, renounced, and abandoned any conditions printed or written upon any stationery used for the purpose of, or in connection with, the submission of their *tender*, which are in conflict with the ***General Conditions of Contract*** and ***Special Conditions of Contract***. *Tenderers* are advised that any *material divergences / qualifications* from the official Conditions or Specification will render their *tenders* liable to disqualification.

3. TENDER INFORMATION

(1) General

- (a) *Tenders* will be liable for rejection unless made out on the official tendering documentation.
- (b) Any alterations effected upon any of the tendering documents must be clearly shown by means of a hand written (black, non-erasable ink), or typed, entry and must be signed in full by the *Tenderer*. **The use of correction fluid is not permitted.**
- (c) *Tenderers* may submit alternative solutions that, in the *Tenderer’s* opinion, are to the *Municipality’s* advantage economically and technically. Full technical details of the alternative *tender(s)* shall be submitted with the tender documents. Alternative *tender(s)* shall be submitted separately.

(2) Obtaining Tender Documentation

All tenders must be submitted on official tender documentation issued, in electronic format, by the eThekweni Municipality. Electronically downloaded documentation (obtainable free of charge) should be printed and suitably bound by tenderer.

(3) Queries Relating to this Tender

Queries can be directed to the person / Department as stated in the ***SCT***.

(4) Briefing Session (Clarification Meeting)

Details of the briefing session are stated in the ***SCT***.

Failure to attend a ***compulsory*** briefing session will invalidate the *tender*. *Tenderers* must sign the attendance list in the name of the tendering entity. *Tenders* will only be evaluated from those tendering entities appearing on the attendance list.

(5) **Closing Date and Delivery of Tender Submissions**

Sealed *tenders* made out on the enclosed Official Tender Form, which shall be signed by or on behalf of the *Tenderer*, and addressed to the City Manager, marked with the appropriate Tender number, must be placed in the **Tender Box** as stated in the **SCT** not later than the **date and time** as stated in the **SCT**, where after they will be opened publicly.

All tender documents **must** be placed directly into the Tender Box and should not be delivered to any other Municipal Department. *Bidders* are advised that *tenders* submitted by post, fax or email **will not** be considered. All couriered documents must be placed directly into the Tender Box and should not be delivered to any other Municipal Department.

Any *tender* received after the closing date and time stated for the receipt thereof **shall not** be accepted for consideration and shall be returned to the *Tenderer*.

(6) **Tender Validity and Withdrawal of Tenders**

Tenders must hold good until 16:00 of the 5th week following the date on which *tenders* are opened, or during such other period as may be specified in the **SCT**. The *Municipality* may, during the period for which *tenders* are to remain open for acceptance, authorize a *Tenderer* to withdraw their *tender* in whole or in part on condition that the *Tenderer* pays to the *Municipality* on demand, a sum of one thousand Rand (R1,000.00). The *Municipality* may, if it thinks fit, waive payment of such sum in whole or in part.

4. **RETURNABLE SCHEDULES, FORMS, CERTIFICATES**

Each *Tenderer* shall complete fully and accurately the following documents and submit these documents with the *tender*:

- (1) **Authority of Signatory:** In terms of Clause 4(5)(c) of the Conditions of Tender.
- (2) **Tax Compliance Status PIN / Tax Clearance Certificate:** SARS has introduced a new Tax Compliance Status System. Tenderers can submit a Tax Compliance Status PIN (TCS PIN) instead of an original Tax Clearance Certificate. This TCS PIN can be used by third parties to certify the taxpayer's real-time compliance status.
- (3) **Declaration of Municipal Fees:** Only those *Bidders* whose municipal fees are fully paid, or those that have concluded acknowledgement of debt agreements with the *Municipality*, are eligible to *tender*.
All *Bidders* must sign the Declaration of Municipal Fees returnable form, declaring that their municipal fees are in order or that acknowledgement of debt agreements have been concluded, and include the relevant account numbers in the declaration. Failure to include account numbers or sign will invalidate the *tender*. The completion of the declaration is also applicable to *Bidders* outside of the eThekweni Municipal Area.
- (4) **Declaration with respect to the Occupational Health and Safety Act:** Acceptance of undertaking in terms of the Occupational Health and Safety Act (Act 85 of 1993) and the relevant Regulations.

(5) **Municipal Bidding Documents** (which includes):

- (a) **MBD 4: Declaration of Interest:** All *Bidders* are to sign the Declaration of Interest wherein they declare any relationship that may exist with an official of the Municipality involved in the evaluation process.
Regulation 44 of the Supply Chain Management Regulations states that a Municipality or Municipal Entity may not make any award to a person:
 - (i) Who is in the service of the state;
 - (ii) If that person is not a natural person, of which any Director, Manager, Principal, Shareholder or Stakeholder is a person in the service of the state; or
 - (iii) Who is an advisor or consultant contracted with the Municipality or municipal entity.
Should a contract be awarded, and it is subsequently established that Regulation 44 has been breached, the Municipality shall have the right to terminate the contract with immediate effect.
- (b) **MBD 5: Declaration for Procurement Above R10 Million** (if applicable): For all procurement expected to exceed R10 million (all applicable taxes included), tenderers must complete this questionnaire.
- (c) **MBD 6.1: Preference Points Claim Form:** For the awarding of Preference Points, *Bidders* are required to complete the attached MBD 6.1 form and return it with their tender submission. Failure on the part of a tenderer to complete and submit this form will be interpreted to mean that preference points for **Specific Goals** are not claimed.
The Municipality reserves the right to require of a tenderer, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the Municipality.
- (d) **MBD 8: Declaration of Bidders Past Supply Chain Management Practices Form:** This form serves as a declaration to be used by municipalities and municipal entities in ensuring that when goods and services are being procured, all reasonable steps are taken to combat the abuse of the supply chain management system.
- (e) **MBD 9: Certificate of Independent Bid Determination:** Section 4(1)(b)(iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms if it involves collusive tendering or tender rigging. In order to give effect to this, the Certificate of Bid Determination must be completed and submitted with the tender.

(5) Official Tender Form (see Section 9)**(a) Legal Status of Tenderer**

It is essential for the purpose of entering into a legal contract that *Bidders* state on the Official Tender Form, under "Name and Address of Tenderer ", their full legal status:

- (i) the full registered name of the company making a *tender*; or
- (ii) if the *Tenderer* is a person conducting business under a recognised trading name then:
 - State the name of the person(s);
 - State recognised trading name; and
 - State whether an owner, co-owner, proprietor, etc.

(b) Signing of Official Tender Form

Failure of a *Tenderer* to complete, in its entirety, and sign the Official Tender Form will invalidate the *tender*.

(c) Authority of Signatory

Bidders are to complete and sign the Authority of Signatory returnable document, and attach the required additional documents.

(d) Differences or Discrepancies

Should there be any difference or discrepancy between the prices or price contained in the Official Tender Form and those contained in any covering letter from the *Tenderer*, the prices or price contained in the Official Tender Form shall prevail.

(6) Any additional Schedules, Forms, or Certificates as stated in the SCT.**5. INFORMATION TO BE SUPPLIED REGARDING SUB-CONTRACTORS**

Bidders are to state in their *tenders*, or covering letters, whether, if the contract were to be awarded to them, the whole of the work would be executed by them in their own workshop / factory. If the answer is in the negative, they are required to state which part(s) would be handed to sub-contractors and the name and address of such sub-contractors.

6. SAMPLES

Bidders may be required to state where samples of the full range of products can be inspected or be required to submit samples for inspection prior to the closing date of the *tender*.

7. MANUFACTURERS

The names of the manufacturers of the goods or equipment offered must be stated in the *tender*.

Bidders who are not manufacturers, accredited distributors, or agents must provide a valid agreement / Joint Venture Agreement, entered into with the manufacturer, accredited distributors, or agents, with their submission. This agreement must meet all the requirements as laid down in the *tender* document, and must cover the contract period.

8. CLARIFICATION

The Head: Supply Chain Management Unit, or an authorized representative, may request clarification or further information on any aspect of the *tender*. The *Tenderer must* supply the requested information within the time specified. Failure to comply will render the *tender* non-responsive.

9. PRICING

Bidders would be precluded from this *tender* if their pricing structure deviates from the Official Tender Form.

(1) Nett Prices

All prices shall be quoted in South African currency (Rand) after deduction of any brokerage or discount allowed to the Municipality.

(2) Unit Prices

Bidders shall quote only one price in respect of each item. Such price is to hold good for the full duration of the contract period, being subject to variation only in accordance with specified criteria, as stated in the *Conditions of Contract*.

(3) Firm Tenders

Bidders may submit firm prices for each 12 month period. These prices shall be free from all fluctuations, including any statutory increases.

(4) Value Added Tax (V.A.T)

Prices exclusive and inclusive of VAT must be stated separately on the Official Tender Form.

10. ESTIMATED QUANTITIES

The estimated quantities are set out in Section 8 : Bill of Quantities / Schedule of Rates/Activities which forms part of the official tender documents. The quantities are stated purely for the information of the *Bidders* and are in order to ascertain an estimated total contract price. The *Supplier* will, however, be bound to supply whatever quantity or quantities the *Municipality* may actually require, and may exceed, or be less than, the estimated quantities stated.

11. DELIVERY, RISK, PACKAGES, ETC

- (1) Unless otherwise provided, all goods are to be supplied only against the form of order issued by the *Municipality*.
- (2) *Bidders* shall quote a unit price which shall include delivery to the specified delivery point, as stated in the *SCT*.
- (3) The risk in all goods purchased by the *Municipality* under the contract shall remain with the *Supplier* until such goods shall have been duly delivered.
- (4) *Bidders* shall clearly state the period within which delivery will be made after receipt of the official order, as this may be material in the adjudication of the *tender*.

12. RATES OF EXCHANGE

- (1) Where the goods are imported the *Supplier* shall, within seven days of date of official Purchase Order, arrange through their bankers for the foreign commitment to be covered forward down to the Rand in order to fix the rate of exchange. The *Supplier* shall notify the *Municipality* as soon as possible thereafter regarding the rate which has been fixed on such forward exchange.

Any increase or decrease between the basic rate of exchange as at a date seven days prior to the date of closing of *tenders* and that existing at the date of establishment of the forward exchange cover within the period stipulated above shall be paid or deducted by the Municipality. Upon the failure of the *Supplier* to arrange forward exchange cover, the *Supplier* shall be liable should there be any increase in the basic rate of exchange occurring after the last mentioned date.

The bank charges incurred in obtaining the forward exchange cover shall be for the *Municipality's* account.

- (2) The *Supplier* shall on request:
- Submit documentary proof of the rate of exchange; and
 - When an adjustment is claimed in terms of this sub-clause, whether by the *Supplier* or the *Municipality*, submit documentary proof to the satisfaction of the Deputy City Manager: Treasury in respect of such claim.

13. IMPORT PERMITS

- (1) In order to minimise special importation, *Bidders* should, where possible, have recourse to local suppliers and / or manufacturers.
- (2) *Bidders* must state whether their *tender* is dependent upon the issue of a special import permit or whether they are able to supply the goods by making use of the import facilities available to them.
- (3) In the event of a tender being dependent upon the issue of a special import permit, application for such special import permit shall be made by the Tenderer, unless otherwise provided for in the *SCT*.

14. EVALUATION PROCESS

The procedure for evaluation of responsive Tender Offers will be in accordance with the eThekweni Municipality's current SCM Policy and the Preferential Procurement Policy Framework Act (5 of 2000), and the Preferential Procurement Policy Framework Act Regulations (November 2022).

Details of additional evaluation criteria, if applicable, are stated in the *SCT*.

Evaluation points for price and preference will only be calculated for *Bidders* who comply with the contractual and technical specification, and if applicable, have attained the minimum Functionality Score as stated in the *SCT*.

The evaluation process of responsive *tenders* will be as follows:

- Score each *tender* in respect of the financial offer made and preferences claimed (if any);
- Calculate the total number of evaluation points (T_{EV}) in accordance with the following formula:

$$T_{EV} = N_{FO} + N_P$$
 where: N_{FO} : is the number of evaluation points awarded for the financial offer; and N_P : is the number of evaluation points awarded for preferences claimed.
- Rank *tenders* from the highest number of evaluation points to the lowest.
- Recommend the *Tenderer* with the highest number of evaluation points for the award of the contract, unless there are compelling and justifiable reasons not to do so.
- Rescore and re-rank all *Bidders* should there be compelling and justifiable reasons not to recommend the *Tenderer* with the highest number of evaluation points, and recommend the *Tenderer* with the highest number of evaluation points, unless there are compelling and justifiable reasons not to do so, and the process set out in this sub-clause is repeated.

(1) Evaluation points awarded for the financial offer:

Reference is to be made to the Special Conditions of Tender (*SCT*), and returnable form 5(c) in Section 4.

INCOME-GENERATING CONTRACTS

The financial offer will be scored using the formula:

$$N_{FO} = W \left(1 + \frac{Pt - P_{max}}{P_{max}} \right)$$

GOODS and SERVICES

The financial offer will be scored using the formula:

$$N_{FO} = W \left(1 - \frac{Pt - P_{min}}{P_{min}} \right)$$

Where the value of W is:

- (a) **90** where the financial value inclusive of VAT of all responsive *tenders* received have a value in excess of R 50,000,000; OR
- 80** where the financial value inclusive of VAT of one or more responsive *tenders* offers have a value that equals or is less than R 50,000,000.
- It is unclear** (at the time of advertising) which of the two preference point systems applies. Either the 80/20 or 90/10 preference point system will apply, determined by the price offered by the lowest acceptable tender.

(b) **P_{max}** is the comparative offer of the most favourable comparative offer (highest acceptable tender).

(c) **P_{min}** is the comparative offer of the most favourable comparative offer (lowest acceptable tender).

(d) **P_t** is the comparative offer of the *tender* offer under consideration.

(2) Evaluation points awarded for preference:

The **Specific Goals** for Preference Points are specified in the *SCT*.

15. BRIBERY AND COMMUNICATION WITH COUNCILLORS / OFFICIALS**(1) Bribery**

No *Tenderer* shall offer, promise or give to any person or person connected with a *tender* or the awarding of a contract, any gratuity, bonus or discount etc, in connection with the obtaining of a contract.

(2) Communication, Councillors and Officials

A *Tenderer* shall not in any way communicate with a member of the *Municipality* or with any official of the *Municipality* on a question affecting any contract for the supply of goods or for any work, undertaking or services which is the subject of a *tender* during the period between the closing date for receipt of *tenders* and the dispatch of the written notification of the *Municipality's* decision on the award of the contract; provided that a *Tenderer* shall not hereby be precluded:

- (a) At the request of the Head: SCM Unit, or an authorized representative, from furnishing him with additional information or with a sample or specimen for testing purposes or otherwise from giving a demonstration so as to enable the recommendation to the Bid Committee on the award of the contract to be formulated;
- (b) From obtaining from the Head : SCM Unit, or an authorised representative, information as to the date upon which the award of the contract is likely to be made, or, after the decision upon the award has been made by the *Municipality* or any Committee to which the *Municipality* has delegated its powers, information as to the nature of the decision or such information as was publicly disclosed at the opening of *tenders* or from submitting to the Accounting Officer in writing any communication relating to their *tender* or the award of the contract or a request for leave to withdraw their *tender*; and
- (c) Provided further that nothing contained herein shall be construed so as to prevent information being sought and obtained from an Official in regard to any decision taken at an open Municipal meeting, or any Committee to which the *Municipality* has delegated its powers.

A contravention of subsection (1) and / or (2), or an attempt to contravene such subsection, shall be reported to the Accounting Officer, who may on receipt of such report disqualify the *tender* of the *Tenderer* concerned.

16. NEGOTIATIONS WITH PREFERRED BIDDERS

The *Municipality* reserves the right to invoke Regulation 24 of Municipal Finance Management Act if required.

- (1) The Accounting Officer may negotiate the final terms of a contract with *Bidders* identified through a competitive tendering process as preferred *Bidders*, provided that such negotiation:
 - Does not allow any preferred *Tenderer* a second or unfair opportunity;
 - Is not to the detriment of any other *Tenderer* ; and
 - Does not lead to a higher price than the *tender* as submitted.
- (2) Minutes of such negotiations must be kept for record purposes.
- (3) Such negotiation may be delegated by the Accounting Officer.

17. CANCELLATION OF TENDER PROCESS

The municipality is entitled to cancel the tender at any time before the award of a tender and the decision to cancel the tender shall be published in the same manner in which the original tender invitation was advertised. The Municipality shall, in no way, be liable for any damages whatsoever, including, without limitation, damages for loss of profit, in any way connected with the cancellation of this bid.

18. ACCEPTANCE OF BID

- (1) The *Municipality* does not bind itself to accept the lowest or any *tender*, and reserves the right to accept the whole or any part of a *tender* to place orders.
- (2) The *Municipality* reserves the right to accept more than one technically and contractually compliant *tender* for part or the whole of the contract and to place orders on the price and availability.
- (3) *Bidders* shall not bind the *Municipality* to any minimum quantity per order.
- (4) The successful *Tenderer* (s) shall be bound to provide any quantities stipulated in the specification.
- (5) Tenders will only be accepted on condition that:
 - (a) The *tender* is signed by a person authorised to sign on behalf of the *Tenderer* .
 - (b) A valid (at time of close of tenders), original, Tax Clearance Certificate OR Tax Compliance Status PIN is included with the *tender* submission. Both should have sufficient validity to ensure the process is adequately covered;

- (7) Change of Ownership or Major Policy: Where it is known to a *Tenderer* that a change in ownership or major policy (of the tendering entity) will occur, or is likely to occur, during a specified contract period, the scope and effect thereof must be fully defined in a covering letter to be submitted with the *tender*.
- (8) Purchase of Goods From Other Sources: Nothing contained in this contract shall be held to restrain the *Municipality* from purchasing from persons other than the *Supplier*, any of the goods described or referred to in this contract, if it shall in its discretion think fit to do so.
- (9) Capability and Breach of Contract: Tenderers that do not have the capability of undertaking this enquiry in terms of the requirements of the contract or have been in breach of contract previously will not be considered.

20. APPEALS

- ¹ Includes price quotations, advertised competitive bids, limited bids and proposals.
- ² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.
- ³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

1. Definitions

The following terms shall be interpreted as indicated:

- 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
- 1.10 "Delivery into consignee store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the goods are so delivered and a valid receipt is obtained.
- 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.

- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the goods covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price, which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25 "Supplier" means the successful bidder who is awarded the contract to maintain and administer the required and specified service(s) to the State.
- 1.26 "Tort" means in breach of contract.
- 1.27 "Turnkey" means a procurement process where one service provider assumes total responsibility for all aspects of the project and delivers the full end product / service required by the contract.
- 1.28 "Written" or "in writing" means hand-written in ink or any form of electronic or mechanical writing.

2. Application

- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services (excluding professional services related to the building and construction industry), sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific goods, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General

- 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2 Invitations to bid are usually published in locally distributed news media and on the municipality/municipal entity website.

4. Standards

- 4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

5. Use of contract documents and information inspection

- 5.1 The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
- 5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
- 5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. Patent Rights

- 6.1 The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.
- 6.2 When a supplier developed documentation / projects for the municipality / municipal entity, the intellectual, copy and patent rights or ownership of such documents or projects will vest in the municipality / municipal entity.

7. Performance security

- 7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the [amount specified in SCC](#).
- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3 The performance security shall be denominated in the currency of the contract or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
- (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
 - (b) a cashier's or certified cheque.
- 7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, [unless otherwise specified](#).

8. Inspections, tests and analyses

- 8.1 All pre-bidding testing will be for the account of the bidder.
- 8.2 If it is a bid condition that goods to be produced or services to be rendered should at any stage be subject to inspections, tests and analyses, the bidder or contractor's premises shall be open, at all reasonable hours, for inspection by a representative of the purchaser or organization acting on behalf of the purchaser.

- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.

- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the goods to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.

- 8.5 Where the goods or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such goods or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.

- 8.6 Goods and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.

- 8.7 Any contract goods may on or after delivery be inspected, tested or analysed and may be rejected if found not to comply with the requirements of the contract. Such rejected goods shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with goods, which do comply with the requirements of the contract. Failing such removal the rejected goods shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute goods forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected goods, purchase such goods as may be necessary at the expense of the supplier.

- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 22 of GCC.

9. Packing

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.

- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, [including additional requirements](#), if any, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents

- 10.1 Delivery of the goods and arrangements for shipping and clearance obligations, shall be made by the supplier in accordance with the terms [specified in the contract](#).

11. Insurance

- 11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery [in the manner specified](#).

12. Transportation

- 12.1 Should a price other than an all-inclusive delivered price be required, [this shall be specified](#).

13. Incidental Services

13.1 The supplier may be required to provide any or all of the following services, **including additional services**, if any:

- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
- (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
- (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
- (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

14. Spare parts

14.1 **As specified**, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and;
- (b) in the event of termination of production of the spare parts:
 - (i) advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, **unless specified otherwise**.

15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

15.4 Upon receipt of such notice, the supplier shall, **within the period specified** and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.

15.5 If the supplier, having been notified, fails to remedy the defect(s) **within the period specified**, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

16. Payment

16.1 The method and conditions of payment to be made to the supplier under this contract **shall be specified**.

16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract.

16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.

16.4 Payment will be made in Rand **unless otherwise stipulated**.

17. Prices

17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any **price adjustments authorized** or in the purchaser's request for bid validity extension, as the case may be.

18. Variation orders

18.1 In cases where the estimated value of the envisaged changes in purchase does not vary more than 15% of the total value of the original contract, the contractor may be instructed to deliver the goods or render the services as such. In cases of measurable quantities, the contractor may be approached to reduce the unit price, and such offers may be accepted provided that there is no escalation in price.

19. Assignment

19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

20. Subcontracts

20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

21. Delays in the supplier's performance

21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the **time schedule prescribed** by the purchaser in the contract.

21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.

21.3 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the goods are required, or the supplier's services are not readily available.

- 21.4 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 22.2 without the application of penalties.
- 21.5 Upon any delay beyond the delivery period in the case of a goods contract, the purchaser shall, without cancelling the contract, be entitled to purchase goods of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.
- 22. Penalties**
- 22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.
- 23. Termination for default**
- 23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
- if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
 - if the supplier fails to perform any other obligation(s) under the contract; or
 - if the supplier, in the judgement of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner, as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
- 23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
- 23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the supplier as having no objection and proceed with the restriction.
- 23.5 Any restriction imposed on any person by the purchaser will, at the discretion of the purchaser, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the purchaser actively associated.
- 23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:
- the name and address of the supplier and / or person restricted by the purchaser;
 - the date of commencement of the restriction
 - the period of restriction; and
 - the reasons for the restriction.
- These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.
- 23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.
- 24. Antidumping and countervailing duties and rights**
- 24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the supplier to the purchaser or the purchaser may deduct such amounts from moneys (if any) which may otherwise be due to the supplier in regard to goods or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.
- 25. Force Majeure**
- 25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.
- 26. Termination for insolvency**
- 26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy, which has accrued or will accrue thereafter to the purchaser.

27. Settlement of Disputes

- 27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4 Notwithstanding any reference to mediation and/or court proceedings herein,
- the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
 - the purchaser shall pay the supplier any monies due the supplier for goods delivered and / or services rendered according to the prescripts of the contract.

28. Limitation of Liability

- 28.1 Except in cases of criminal negligence or wilful misconduct, and in the case of infringement pursuant to Clause 6;
- the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and
 - the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

29. Governing language

- 29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

30. Applicable law

- 30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified.

31. Notices

- 31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.
- 31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

32. Taxes and duties

- 32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid SARS must have certified that the tax matters of the preferred bidder are in order.
- 32.4 No contract shall be concluded with any bidder whose municipal rates and taxes and municipal services charges are in arrears.

33. Transfer of Contracts

- 33.1 The contractor shall not abandon, transfer, cede assign or sublet a contract or part thereof without the written permission of the purchaser.

34. Amendment of contracts

- 34.1 No agreement to amend or vary a contract or order or the conditions, stipulations or provisions thereof shall be valid and of any force unless such agreement to amend or vary is entered into in writing and signed by the contracting parties. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.

35. Prohibition of restrictive practices

- 35.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder(s) is / are or a contractor(s) was / were involved in collusive bidding.
- 35.2 If a bidder(s) or contractor(s) based on reasonable grounds or evidence obtained by the purchaser has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in section 59 of the Competition Act No 89 Of 1998.
- 35.3 If a bidder(s) or contractor(s) has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.

SECTION 6: SPECIAL / ADDITIONAL CONDITIONS OF CONTRACT

The **Conditions of Contract** make reference to the **Special Conditions of Contract (SSC)** for details that apply specifically to this bid. The **Special Conditions of Contract** shall have precedence in the interpretation of any ambiguity or inconsistency between it and the **Conditions of Contract**.

Each item below is cross-referenced to the clause in the **Conditions of Contract** to which it mainly applies.

SCC 1.2 CONTRACT

This is a 36 months contract.

SCC 7.1 PERFORMANCE SECURITY

The liability of the Performance Security shall be Nil.

SCC 10.1 DELIVERY AND DOCUMENTS

In the event of any purchased goods requiring shipment, the contractor will be responsible for any shipping obligations including any associated payment. Equipment delivery shall be at location stipulated in the order.

SCC 12.1 TRANSPORTATION

The tendered rates shall be inclusive of transportation costs.

SCC 15.2 WARRANTY

The successful Service Provider shall be required to provide a replacement device for any faulty device under warranty. The warranty period shall be as stipulated by the equipment manufacturer but not less than 24 months.

The Service Provider must replace a device within 14 days after receiving a written complaint from EThekweni Municipality regarding a faulty device.

SCC 16.1 PAYMENT

The Contractor shall submit to the Department concerned a detailed account which shall reflect the identifying number of each item / service. Payment will be made on this account when checked and substantiated by the authorised official.

Payment for goods received and accepted by the Municipality shall be made no later than 30 days after submission of invoice or claim, provided however that all the terms of the contract are duly complied with.

Payment will be made only to the supplier. Factoring arrangements will not be accepted.

SCC 17 PRICES

Prices are fixed for the first 12-month period, and thereafter adjusted annually using the CPI published by Statistics South Africa.

SCC 21.1 DELAYS IN THE SUPPLIER'S PERFORMANCE

The time schedule for the delivery of goods and performance of services will be determined and agreed upon once the scope of each works has been established.

SCC 22.1 PENALTIES

If the supplier fails to deliver any or all the goods or to perform the services within the period(s) specified in the contract, the purchase shall, without prejudice to its other remedies under the contract, deduct from the contract price (as a penalty):

- A penalty of 10% of the order value for each month delivery is delayed.

ADDITIONAL CONDITIONS OF CONTRACT

ACC1 PERFORMANCE MONITORING & ASSESSMENT OF SERVICE PROVIDERS

For contract awards that are greater than R10m, the Contractor shall be subjected to "Performance Monitoring" assessments in terms of the applicable Section of the Council's current Supply Chain Management Policy.

ACC2 QUALITY OF PRODUCTS

No inferior products will be accepted under this enquiry.

Should there be any cause for complaint against the standard of service or quality of products offered which is not resolved within a period of 10 working days, the Municipality reserves the right to cancel the contract after serving one month's notice, in writing, to the supplier involved. Should such notice be given, the supplier shall nevertheless be obliged to perform the duties covered by the contract up to the date of expiration of the period of notice.

ACC3 SATISFACTORY PERFORMANCE

The supplier shall employ for the purpose of this contract only such personnel as are careful and competent and the Municipality shall be at liberty to object to and require the supplier to remove from the job forthwith any person, including supervisory staff, employed by the supplier who, in the opinion of the Municipality, misconducts himself/herself or is incompetent or negligent in the proper performance of his/her duties and such person shall not again be employed upon this contract without the permission of the Municipality.

ACC4 OCCUPATIONAL INJURIES AND DISEASES ACT

This act replaces the Workmen's Compensation Act:

The supplier shall, before commencement of work, produce documentary proof to the Deputy Municipal Manager, Treasury: Finance that he has complied in all respects with the provisions of the Occupational Injuries and Diseases Act. The supplier undertakes that he/she will perform and comply with all provisions of the Occupational Injuries and Diseases Act and more particularly that he/she will render all returns and pay all assessments for which he/she is liable in terms of such Act.

ACC5 DAMAGE TO PERSONS AND PROPERTY

- (1) The supplier **shall** indemnify and keep indemnified the Council against any claim for death, injury, damage or loss to any person or property whatsoever in respect thereof or in relation thereto.
- (2) The supplier enters into this contract as an independent contractor and shall be solely liable in respect of any claim for death, injury, damage or loss to any person or property whatsoever in respect thereof or in relation thereto.

ACC6 RATE OF EXCHANGE VARIATION

Where the goods are imported the Contractor shall within seven days of date of Official Purchase Order, arrange through his bankers for the foreign commitment to be covered forward down to the Rand in order to fix the rate of exchange. The Contractor shall notify the Municipality as soon as possible thereafter regarding the rate which has been fixed on such forward exchange. The forward cover shall be from a reputable South African bank. The Contractor is to confirm with the employer prior to placing forward cover if the service provider is acceptable.

Any increase or decrease between the basic rate of exchange as at 12:00 on the date of close of the bid and that existing at the date of establishment of the forward exchange cover within the period stipulated above shall be paid or deducted by the Municipality. Upon the failure of the Contractor to arrange forward exchange cover, the Contractor shall be liable should there be an increase in the basic rate of exchange occurring after the last-mentioned date.

The bank charges incurred in obtaining the forward exchange cover must be included in the Tenderer's bid.

ACC7 ESTIMATED QUANTITIES

The quantities stated in Section 8 are applicable for evaluation purposes only. The final quantity of goods and services required shall vary, depending on the total number of actual instances a service/goods will be required over the Contract Period. The rates tendered shall be applicable, irrespective of the total quantity of goods and services procured over the contract's duration.

ACC8 SERVICE PROVIDER OFFICE REQUIREMENTS

The service provider must have, for the duration of the contract, a local presence (within the geographical eThekweni boundary).

ACC9 PRICING FOR NON-SCHEDULED ITEMS

In the case of non-scheduled items such as replacements that were not included in the schedule of rates, the contractor shall source a quote from the OEM and apply the following mark-up:

- a. Up to 15% for items between R1-25 000
- b. Up to 10% for items between R25001 – R75000

The EThekweni Municipality reserves the right to negotiate the mark-up percentage with the appointed Service Provider.

The contractor shall then present his marked-up quotation alongside that of the OEM for verification.

ACC8 Additional Project Team

The contractor shall provide additional technical resources, should the need arise, at a month's notice from the EThekweni Municipality.

ACC10 Workmanship

- a. The site surroundings when the installation is done must be left in the same neat condition as on commencement of installation. Inspection thereof shall be undertaken by the administration staff on site.

- b. The contractor shall return any existing equipment removed on-site to the eThekweni Municipality representative.
- c. Depending on the location of the installation the cable shall be suitably a-fixed to the mounting surface. Conduits and trunking must be fitted appropriately to ensure the adequate concealment of cabling in exposed locations.
- d. There must be no joints made in non-tamper enclosures.
- e. The cables must not be laid in parallel with high current cables.
- f. The contractor must refrain from laying cables over fluorescent lamps.
- g. The contractor must use the correct cable type and configuration.
- h. Cables must be installed in accordance with BS7671 – Requirements for Electrical Installations – IEE Wiring Regulations, Sixteenth Edition.
- i. Cables installed within existing horizontal cable trays shall be secured by plastic cable ties.
- j. Where cables are passing through external walls, the clearance hole must have a bore sleeve which is sealed into the wall, sloping downwards and sealed with a non-hardening waterproof compound.
- k. In instances where cables pass through internal walls, clearance holes shall have bore sleeves installed within the wall.
- l. All cable linking devices together must be of the correct specification as recommended by the manufacturer for the interconnection of devices/equipment.
- m. The communications cabling must be rated for the specified installation over the required distance.

ACC10 Training of Municipal Staff

The successful Service Provider is expected to conduct the skills transfer by offering the on-the-job-training. Skills transfer shall be at no cost to the EThekweni Municipality.

ACC11 PRODUCTS PROPOSED/UNDER DEVELOPMENT

Equipment not readily available from supplier/manufacturing sources shall be specifically excluded from consideration. This condition shall particularly apply to products currently under development or intended to be marketed at some future date (or undergoing qualification or evaluation prior to launch).

ACC12 DAMAGED OR STOLEN GOODS

All purchased goods damaged or stolen in the hands of the Service Provider shall be the responsibility of the Service Provider.

SECTION 7: SCOPE AND SPECIFICATION OF REQUIRED SUPPLY / SERVICES

1. SCOPE OF SUPPLY / SERVICES

The scope of the project is to supply, install and commission access control system in EThekwini Municipal buildings and properties. Further to that, the following work will have to be carried out:

- a. Site Inspection.
- b. Provision of all necessary cabling, accessories, and auxiliaries.
- c. Linking of new sites to the central SQL database.
- d. Migration of existing access control databases to the central SQL database.
- e. Training of council resources on how to maintain and operate the system.
- f. Decommissioning of existing access control systems, where necessary.
- g. Provision of site documentation.

2. GENERAL SYSTEM SPECIFICATIONS

2.1 The offered access control system shall be compatible with the **Impro Portal Enterprise** system that is currently in place in eThekwini Municipality.

2.2 The offered access control system shall facilitate the following methods of controlled access:

- a. Biometric Access, including fingerprint readers, facial recognition readers and contactless fingerprint readers.
- b. 125kHz and 13.56MHz multidiscipline tag readers.
- c. Boom gate and turnstile-controlled access.
- d. Long range UHF readers and License disc scanners for vehicles.
- e. Visitor Management System.

2.3 Where applicable, offered devices shall come with Impro unlocks pre-installed.

2.4 In addition to the above, the service provider shall make provisions for report customisation features on the SQL side of the system.

2.5 The operating temperature and storage temperature of all access control devices shall be between -10°C to 55°C.

2.6 The relative humidity range be between 0 – 95%.

2.7 The access control system shall have adequate EMC protection and shall comply with SANS 50007 and SANS 50003.

2.8 The access control system shall be limited to the following communication standards in its operations:

- a. RS485
- b. Ethernet 10/100 Base

- 2.9 The access control system shall be compatible with various visitor management systems.
- 2.10 The access control system shall be compatible with various HR systems like ERP.
- 2.11 The access control system shall have interfaces for with various I/O devices like relays, sensors and actuators for fire detection and lift homing devices.

3. CONTROLLERS

3.1 Central Controller

- 3.1.1 The central controller shall control a minimum of 48 access control terminals.
- 3.1.2 The central controller shall be fitted with an RS485 port and an ethernet port as a minimum.
- 3.1.3 The central controller shall come with an optional battery pack, supplying up to 4 hours of uninterrupted power.
- 3.1.4 The central controller shall be capable of operating as a door controller, and adhere to 3.2, where necessary.
- 3.1.5 The central controller shall handle up to 10,000 registered users per site.
- 3.1.6 The central controller shall buffer up to 100, 000 transactions in its buffer memory.
- 3.1.7 The central controller shall be capable of operating under offline conditions, where connection to the central server has been lost.
- 3.1.8 The central controller shall be compatible with various peripheral hardware as per 2.1 and 2.10 of the General System Specifications.
- 3.1.9 The controller enclosure shall have an ingress protection of 30.

3.2 Door Controller

- 3.2.1 The door controller shall adhere to 3.1.2 - 3.1.3 of the Central Controller.
- 3.2.2 The door controller shall adhere to 2.1 and 2.10 of the General System Specification.
- 3.2.3 The door controller shall handle up to 2 doors.
- 3.2.4 The door controller shall perform both online and offline validation of each transaction.
- 3.2.5 The door controller shall have an anti-tamper switch.
- 3.2.6 The door controller shall have a minimum of 2 relay outputs.
- 3.2.7 The door controller shall buffer up to 10,000 transactions on its memory.
- 3.2.8 The door controller shall store up to 10,000 registered users on its memory.
- 3.2.9 The door controller enclosure shall have an Ingress Protection of 30.
- 3.2.10 The door controller shall come fitted with back-up power for continuous operation of up to 2 hours.

4. SENSORS AND BIOMETRICS

4.1 Fingerprint Readers

- 4.1.1 The fingerprint readers offered shall be as follows:
- a. An outdoor reader with an ingress protection of at least 65.
 - b. An indoors reader with a colour touchscreen not smaller than 5cm diagonally.
 - c. An indoors reader without a screen.
- 4.1.2 The fingerprint reader shall have a user matching capability of 1:10,000 in 1 second.
- 4.1.3 The fingerprint reader shall display the date, time, and username whenever a transaction occurs.
- 4.1.4 The fingerprint reader shall keep a log of up to a million transactions.
- 4.1.5 The fingerprint reader shall have a duress finger prevention as well as fake finger detection mechanisms.
- 4.1.6 The fingerprint reader shall the capacity to store 500 users, with an option to extend up to 2000 user via license purchases.
- 4.1.7 The fingerprint reader shall have built-in RFID card reader technologies as a minimum. These should include MiFare, iProx and iClass.

4.2 Facial Recognition Terminals

- 4.2.1 The terminal shall adhere to 4.1.7 of the specification.
- 4.2.2 The terminal shall have a recognition speed of less than 1 second.
- 4.2.3 The terminal shall have a 99% accuracy.
- 4.2.4 The terminal shall be a short-range device with a recognition distance of 0.5 to 2m.
- 4.2.5 The terminal shall be capable of operating in most lighting conditions.
- 4.2.6 The terminal shall utilise anti-spoofing algorithms to detect fraudulent entry attempts like the use of photos and masks. These algorithms shall utilise texture analysis and deep learning methods to detect fake faces.
- 4.2.7 The terminal shall have an internal storage capacity of not less than 2000 user biometrics.
- 4.2.8 The terminal shall keep a log not less than 100,000 transactions and events in its internal memory.
- 4.2.9 The terminal shall have an Ingress Protection of 65.

4.3 Long range UHF Reader

- 4.3.1 The UHF terminal shall perform automatic vehicle identification at not less than 7m.
- 4.3.2 The UHF terminal shall utilise passive UHF tags.
- 4.3.3 The UHF terminal shall have an Ingress protection of 65.
- 4.3.4 UHF tags should be based on battery-free, passive technology.

- 4.3.5 The UHF tags should be mountable on windscreen without interference from the substrate. These must break if removed.

4.4 Tag Readers

- 4.4.1 The reader shall utilise both 125kHz and 13.54MHz frequencies.
- 4.4.2 There should be an indoor and an outdoor version of the reader.
- 4.4.3 The size of the reader shall be compact enough to be fitted on most outdoor gooseneck installations.
- 4.4.4 The reader shall have an Ingress protection of 65.
- 4.4.5 The reader shall tamper protection.
- 4.4.6 The reader shall have both a visual and audible status indicator for transaction accepted, declined and device offline.

4.5 Exit No Touch

- 4.5.1 It should be powered from the door terminal.
- 4.5.2 Its detection range should be up to 10 cm.
- 4.5.3 It should emit a certain colour when on standby and change to a different one when activated.
- 4.5.4 It must be made of stainless steel for durability.
- 4.5.5 It must be rated IP 55 or better.

5. PHYSICAL ACCESS CONTROL

5.1 Turnstiles

Each product on offer shall have the following minimum design parameters/features/functions:

- 5.1.1 The turnstile shall be a four arm single turnstile, allowing passage in both directions.
- 5.1.2 The turnstile shall be suitable for outdoor application.
- 5.1.3 The turnstile shall be controlled by the specified access control system.
- 5.1.4 The turnstile shall be as maintenance free as possible.
- 5.1.5 The turnstile shall be configurable to remain locked or freely rotate in the event of a power failure.
- 5.1.6 The turnstile's frame shall be manufactured from mild steel hot dip galvanized to ensure corrosion resistance.
- 5.1.7 The turnstile's spindle shall comprise of a shaft and an arm and shall be GRADE 304 stainless steel.
- 5.1.8 The turnstile's spindle arms shall be hairpin design.
- 5.1.9 The turnstile shall allow a minimum passage frequency of 15 persons per minute.
- 5.1.10 The turnstile shall have roller bearings with seals on the top and roller taper bearings on the bottom to withstand axial and radial loads.

- 5.1.11 The turnstile shall have polyurethane pawls operating on a locking drum.
- 5.1.12 The turnstile shall have a minimum 50mm mild steel tapered shaft with drive key.
- 5.1.13 The turnstile shall have a flexible drive with moulded rubber bushes to prevent shock loading on head components.
- 5.1.14 The turnstile's edges shall be rounded, and all surfaces smoothed and free of sharp protrusions to prevent injury to users.
- 5.1.15 The turnstile's header box shall be IP55 rated.
- 5.1.16 The turnstile shall have an enclosure that is weatherproof into which the tag readers will be installed.
- 5.1.17 The turnstile shall be come fitted with two (2) 12V 7.2Ah batteries for back-up purposes.

5.2 Double Full Height Turnstile

- 5.2.1 It shall have all the features in 5.1.1 to 5.1.18 above.
- 5.2.2 Entry and exit can happen on either side of the centre piece of the turnstile.

5.3 Waist High Turnstiles

A. Single Waste High Turnstiles

- 5.3.1 The turnstile shall comprise of three arms.
- 5.3.2 The turnstile shall possess auto time-out locking to enhance security.
- 5.3.3 The turnstile shall a pulse time of not more than a second
- 5.3.4 The turnstile shall draw current of not more than 15VA at12V when activated.
- 5.3.5 The turnstile shall be configurable for bidirectional operation.
- 5.3.6 The turnstile arms shall be made of mild or stainless steel and shall be polished and be well rounded off to prevent any injuries due to roughness or sharpness of edges.
- 5.3.7 The turnstile stand shall be able to house the power supply and reader interface.
- 5.3.8 The in and or out reads shall be achievable depending to the site requirement.
- 5.3.9 The turnstile centering mechanism shall be cushioned by hydraulic shock absorber.
- 5.3.10 The turnstile's housing mechanism (for the power supply unit and reader interface) and pedestal shall be fabricated from carbon steel and powder coated.
- 5.3.11 The turnstile shall be come fitted with two (2) 12V 7.2Ah batteries for back-up purposes.
- 5.3.12 The turnstile shall be configurable to free-wheel or remain locked in event of a power failure.
- 5.3.13 The turnstile should be possible to couple to metal detector for emergency lock up activation.
- 5.3.14 It shall allow of counting of entrants to a facility and remote monitoring of same.

5.3.15 It shall have an electronic random search feature for theft control.

5.3.16 It shall achieve the damping control through the usage of gas control technology.

B. Double waist height turnstile

5.3.17 It shall comprise of six arms, three on either side of the stand as shown in the figure below.

5.3.18 It shall have the same features/functionalities/ capabilities as those reflected in 5.3.1 to 5.3.2.

5.4 Paraplegic Gates

5.4.1 The gate shall be designed to cater for wheelchair access.

5.4.2 It should be operable via industrial push button and or readers (biometric and proximity).

5.4.3 The gate must be able to open 90 degrees in and out.

5.4.4 The gate shall automatically go into lock state when it closes using an electromagnetic lock.

5.4.5 The material used for the manufacturing of the gate shall be either mild steel or stainless steel.

5.4.6 The gate shall be come fitted with two (2) 12V 7.2Ah batteries for back-up purposes.

5.5 Drop Arm Barrier

5.5.1 shall have toughened glass arm and be able to withstand high traffic flow.

5.5.2 It shall be made of stainless steel or powder coated mild steel housing.

5.5.3 It shall allow passage of people more than 15 per minute.

5.5.4 It shall be configurable to open automatically in the event of fire and or power failures.

5.5.5 It shall generate no noise during its operation.

5.5.6 It shall allow passage of wheelchairs.

5.5.7 It shall be a free-standing unit and bolt-able onto the floor.

5.6 Boom gates.

5.6.1 The gate shall come in the following variations:

- a. The standard 4.5m boom gate.
- b. Jack-knife boom gate.

5.6.2 The gate casing shall be of a stainless steel 3CR12 material, with ventilation louvers and epoxy powder coated.

5.6.3 The gate casing side door shall be lockable and hinged and the lid shall be internally fixed and removed.

- 5.6.4 The gate shall be installed onto the mounting surface using rawl bolts.
- 5.6.5 The boom pole shall be lightweight extruded aluminium tubing.
- 5.6.6 The boom pole finish shall be vinyl coated red and white.
- 5.6.7 The gate shall automatically raise the pole to its default 90° position when there's a power outage.
- 5.6.8 The gate's arm drive mechanism shall be rotary arm/crank with over centre arm lock at raised and lowered positions.
- 5.6.9 The gate shall be fitted with arm damping with rubber buffering end stops.
- 5.6.10 Shall be able to operate on the specified access control systems.
- 5.6.11 Adjustable arm counterbalance tension spring, sized according to arm length.
- 5.6.12 Memory, non-memory input function.
- 5.6.13 Remote raise, lower input function.
- 5.6.14 Input duration 0,1 seconds minimum.
- 5.6.15 Toggle switch function, raise auto, and lower.
- 5.6.16 Integral timer, +/-120 seconds if no vehicle passes.
- 5.6.17 The gate shall utilise the following vehicle detection mechanisms:
 - a. Magnetic Safety Loops.
 - b. Beam detectors.
- 5.6.18 The gate shall come fitted with a break away coupler to prevent the boom from being damaged if it knocked accidentally.
- 5.6.19 The gate shall be fitted with back-up power for continuous operation of more than 2 hours during a power outage.

5.7 Goosenecks

A. Single height

- 5.7.1 It shall be of the height conducive for car drivers.
- 5.7.2 It shall be able to accommodate MDR readers.
- 5.7.3 It shall be modifiable for mounting biometric readers.
- 5.7.4 It shall have a hole through which the cabling will be run.
- 5.7.5 It shall be rigid and durable.
- 5.7.6 It shall be galvanised to ensure its durability.
- 5.7.7 It shall come pre-drilled.

B. Double height

- 5.7.8 It shall have two reader positions, lower one for cars and the higher placed one for trucks
- 5.7.9 It shall possess all other features referred to from after 3.6.17.1.2 to 3.6.17.1.8 above.

6. INTERCOMS

6.1 Audio Intercom

- 6.1.1 The intercom shall come in the following configurations:
 - a. A 1:1 kit with one (1) door and one (1) reception handset.
 - b. A 1:2 kit, where there's one (1) door station and two (2) reception handset.
 - c. A 1:3 kit where there's one (1) door station and three (3) reception handset.
- 6.1.2 The intercom shall operate in full duplex mode.
- 6.1.3 The intercom shall allow communication between the visitor which will be by the door and the receptionist.
- 6.1.4 The intercom shall have an audible buzzer button that alerts the receptionist of an outside presence.
- 6.1.5 The intercom operate as follows:
 - a. An outside presence presses the door station to alert reception.
 - b. An audible alert is then generated on the reception handset.
The receptionist manning the station, establishes communication, and then presses a button on the handset to open the door.

6.2 Video Intercom

- 6.2.1 The intercom shall adhere to the specification set out in the 6.1.1 to 6.1.5.
- 6.2.2 The intercom shall be an IP based system.
- 6.2.3 The intercom, in addition to point 6.1.6 shall provide a video feed to reception, showing the outsider.
- 6.2.4 This means the handset and the door stations shall be as follows:
 - 8.1.1 The handset shall have a full colour screen not less 4 inches in diagonal size.
 - 8.1.2 The door station shall be fitted with a camera with a resolution of not less than 2 megapixels.
- 6.2.5 The intercom handset shall be capable of monitoring the door station and its surrounding without any alert.
- 6.2.6 The handset shall have an adjustable volume.
- 6.2.7 It shall be possible to adjust the brightness of the screen.

7. OVERRIDES

7.1 Key-Switch

Each product on offer shall have the following minimum design parameters/features/functions

- 7.1.1 The switching ON/OFF shall be standard.

- 7.1.2 Slimline
- 7.1.3 Two LED
- 7.1.4 Tamper switch.
- 7.1.5 Weatherproof metal enclosure for indoor and outdoor
- 7.1.6 Minimum of 3 keys

7.2 Break Glass Unit

Each product on offer shall have the following minimum design parameters/features/functions:

- 7.2.1 It shall be a Resettable Break Glass.
- 7.2.2 It shall be a Double pole version.
- 7.2.3 It shall come with a Reset key.
- 7.2.4 It shall be surface mounted.
- 7.2.5 It shall have a green thermoplastic housing.
- 7.2.6 Comply with CE requirement.
- 7.2.7 The poles shall be of silver and shall transfer when glass is broken.
- 7.2.8 Shall have a call point lens protective cover which shall have a clear finish and that shall prevent the accidental operation of the emergency break glass unit.
- 7.2.9 It shall be suitable for indoor and outdoor application.
- 7.2.10 With yellow drop-down flag signifying that the door is on override.

8. LOCKS

8.1 Magnetic lock

Each product on offer shall have the following minimum design parameters/features/functions as a minimum:

- 8.1.1 The lock shall be suitable to be mounted on the front or the side of timber, aluminium, and steel frame doors.
- 8.1.2 The lock shall be suitable for indoor and outdoor.
- 8.1.3 The lock shall be surface mounted.
- 8.1.4 The lock shall have a stainless-steel housing.
- 8.1.5 The lock's armature plate material shall be steel plated.
- 8.1.6 The lock's Shall comprise of a magnet and armature.
- 8.1.7 Vandal and weather resistant.

8.2 Shear lock

- 8.2.1 The shear lock shall have a failsafe feature allowing it to unlock in case of mains outage.
- 8.2.2 It shall be equipped with alarm input for determining if the magnet is connected to the armature.

- 8.2.3 It must have the normally open and normally closed circuit for compatibility with different alarm systems.
- 8.2.4 It shall also have visible indicators of the status of the lock (lock or unlock)
- 8.2.5 It shall be either a flush or surface mount type.
- 8.2.6 It shall be capable of being mount on the glass fixing for doors and over panel.
- 8.2.7 It shall have up to 1000Kg shear force
- 8.2.8 It shall operate from power source of 12 to 24 volts range.

8.3 Electronic Cisa lock (external and internal)

The lock on offer must have the following features/capabilities/functionalities as a minimum:

- 8.3.1 The lock shall use a 12V power supply.
 - 8.3.2 The lock must be a surface mounted.
 - 8.3.3 The lock shall make the least amount of noise during opening and closing operations.
 - 8.3.4 The lock shall have reduced gate rebounding effect.

- It shall be equipped with failsafe.

8.4 Electromechanical lock (Abloy)

- 8.4.1 It must be suited for both internal and external usage.
- 8.4.2 Adjustable back set.
- 8.4.3 Non-handed, symmetrical trigger bolt
- 8.4.4 Immediate release of deadlocking
- 8.4.5 Configurable fail locked / fail unlocked.
- 8.4.6 Wide operating voltage 12-24VDC
- 8.4.7 The lock must have a double action bolt construction for durable.
- 8.4.8 It should operate within temperature ranges from below 0 to 60°C.

8.5 Magnetic Contact

Each product on offer shall have the following minimum design parameters/features/functions:

- 8.5.1 Use a magnetic spacer when mounting contacts on steel doors.
- 8.5.2 Only self-tapping screws or epoxy shall be used as an adhesive medium.

- 8.5.3 Steel expandable door loops shall be used.

8.6 Door Closer

- 8.6.1 The door closer shall have a compact body size.
- 8.6.2 The door closer shall have a highly efficient rack and pinion mechanism incorporating a fully supported hardened forged steel piston and a harden steel precision made pinion.
- 8.6.3 The door closer shall an adjustable valve with a built-in thermostat and hydraulic fluid shall provide constant closing speeds.
- 8.6.4 The door closer shall a quality, precision machined aluminium body and zinc plated arm assembly shall provide resistance to corrosion. All parts shall be coated with three coverings of lacquer.
- 8.6.5 The door closer's mechanisms and compression spring shall be immersed in hydraulic fluid shall provide a smooth, secure and permanent door closing.
- 8.6.6 The door closer shall have a built-in pressure relief valve that prevent possible damaged caused by forceful closing.
- 8.6.7 The door closer shall be fully reversible for clockwise or anti-clockwise closing without adjustments.

9. ACCESSORIES

9.1 Industrial Push Button

Each product on offer shall have the following minimum design parameters/features/functions:

- 9.1.1 A green flush button head, IP65 rated, 22mm diameter.
- 9.1.2 Die cast aluminium enclosure, grey, IP65 rated.
- 9.1.3 Contact Blocks and support base.

9.2 Sound bombs

Each product on offer shall have the following minimum design parameters/features/functions:

- 9.2.1 It shall be configurable to sound an alarm if the door is kept open for prolonged periods.
- 9.2.2 It shall be of ultra-compact size.

9.3.3 The tag shall have a unique identity number.

9.3.4 The tag shall be a passive device.

9.3.5 The tag shall be robust with the facility to be added to e.g. key rings. ABS

10. VISITOR MANAGEMENT SYSTEM

10.1 System Requirements

10.1.1 The VMS shall have Impro Portal APIs for seamless integration.

10.1.2 The VMS shall be web-based. Deployment shall be made on eThekweni Municipality's infrastructure, not external cloud service provider.

10.1.3 The VMS shall be able to integrate with MS Outlook email platform.

10.1.4 The VMS shall have a visitor/vehicle pre-booking feature that allows users to pre-book visitors and vehicles days in advance.

10.1.5 The VMS shall notify the user when a visitor/vehicle has arrived, either via email or SMS.

10.1.6 The VMS shall log essential information arrival and departure time, type of authorization etc.

10.1.7 VMS shall be capable of generating a report on every visitor and vehicle that has entered the premises. The report shall contain information like visitor ID, Vehicle License disk, picture, time in and timeout and purpose of visit.

10.1.8 The VMS shall have a customisable feature that allows the user to capture the following information daily:

- a. Vehicle License Disk.
- b. Pictures of the vehicle showing its current condition.
- c. Odometer reading of the vehicle.

10.1.9 The VMS shall enable the user to generate a transaction report on every personnel or vehicle entering the building.

10.2 Vehicle Scanner Terminal

The VMS shall come with a handheld terminal device:

- 10.2.1 The terminal device shall scan and decode the PDF417 barcode on a vehicles and drivers licenses.
- 10.2.2 The terminal device shall have an offline data retention capability.
- 10.2.3 The terminal device shall give the user the following scanning options:
 - a. Pedestrian ID
 - b. Vehicle
 - c. Token
- 10.2.4 The terminal device shall timestamp every transaction.
- 10.2.5 The terminal shall employ the use of WPA2 encryption standards when transmitting over Wi-Fi. The device's data retention methods shall comply with the POPI act of 2013.
- 10.2.6 The terminal shall have configurable fields for pedestrians, such as name, surname, reason for visit, etc.
- 10.2.7 The terminal shall have RFID/NFC as an option.
- 10.2.8 The VMS terminal shall utilise the following communication standards as a minimum:
 - a) Wireless LAN,
 - b) GSM,
 - c) LTE.
- 10.2.9 The terminal shall have an Ingress Protection rating of 67 and 68.
- 10.2.10 The terminal shall have a shockproof ruggedness.
- 10.2.11 The terminal shall have a minimum of 3000mAh.
- 10.2.12 The terminal shall come with a charging stand.
- 10.2.13 The scanning device shall have a minimum ingress protection of 65.
- 10.2.14 The scanning device shall withstand a 1.0m drop on hard surfaces.
