1. APPOINTMENT OF A SERVICE PROVIDER

Prospective service providers with suitable qualifications and experience are sourced to submit proposals for Preventative Maintenance of ICT systems. The appointed service provider will conduct preventative maintenance in three data centers (Head office, Zoo and Spring field FM) and All JCPZ CCTV cameras over a period of (12) months.

Proposals are to be submitted in line with terms of reference stipulated below.

2. BACKGROUND

Johannesburg City Parks and Zoo (JCPZ) has preventative maintenance contract that is currently running that is soon coming to end, hence a new contract is sought for a similar service. JCPZ has installed in its datacenters generators (Head Office only), fire suppression system, air conditioning system, uninterrupted power supply and video surveillance to ensure optimal operation of ICT equipment. It is against this background that the JCPZ seeks to appoint a service provider to conduct preventative maintenance on the above-mentioned equipment.

3. SCOPE OF WORK/DELIVERABLES

Objectives

- To identify maintenance actions on ICT equipment and incorporate into the preventative maintenance program for the required activities.
- To minimize breakdown of equipment.
- To maintain satisfactory equipment conditions and improve equipment reliability.
