1. BACKGROUND

This background document outlines the rationale for procuring specialized, high-energy drinks and food bars for firefighters, designed to sustain performance during, and aid recovery after, high-intensity incidents. It highlights key nutritional, logistical, and safety requirements necessary for purchasing specifications and the objective is to ensure consistent and steady supply to Emergency Services personnel.

2. PROJECT SCOPE

It is the intent of the City of Tshwane that these specifications cover the supply and delivery of rehabilitation stock items for a period not exceeding twelve (12) months.

The project involves sourcing, supplying, and delivering specific, nutritionally balanced food items to designated fire stations or incident sites on an "as-and-when-required" basis.

Energy Drinks/Electrolyte Solutions: Specifically, carbohydrate/electrolyte beverages (3-5% carb concentration) or Oral Rehydration Solutions (ORS) to rapidly replace sodium/potassium lost through sweat.

Energy/Nutritional Bars: High-energy, ready-to-eat bars (e.g., protein bars, oat bars, fruit-based bars) that provide sustained energy without excessive saturated fats.

Packaging Requirements: Products must be easily consumable in the field, portable, and durable in high-heat environments.

Items must match the agreed-upon nutritional specifications.

Products must be delivered in proper hygienic packaging.

Quantities delivered must match the requisition form (Rehab/Incident Form).

With a view of obtaining the best results and the most acceptable product for service in the Emergency Services Department, these specifications cover only the general requirements. Minor details of materials where not otherwise specified are left to the discretion of the bidder.

All goods shall be of the highest quality. They shall be protected from damage; any damaged, flawed or defaced materials shall be rejected and replaced at a cost to the service provider.

The supplier shall warrant that the materials shall be of the highest grade, in accordance with the best practices. The service provider shall warrant that all the Nutrient Profile: Drinks: Electrolyte drinks must contain sodium, potassium, and carbohydrates (30–50 grams per liter of water). Bars: Balanced macronutrients, focusing on carbohydrates for energy and protein for muscle maintenance.

Compliance: All products must comply with local health regulations (e.g., SABS, approved, or equivalent local food safety standards).

Shelf Life: Items must have a minimum of 6–12 months remaining shelf life upon delivery.

The supplier shall further warrant that all goods supplied under tender award shall have no defect, from any act or omission of the supplier that may develop under normal use of the supplied goods in the conditions prevailing in the country of destination. The service providers will be using his/her own transport. Delivery and off-loading must be included in the price. The tender will be awarded to one bidder.

3. DELIVERABLES

- **ITEM1: 500ML SPORT ENERGY DRINK IN A PACK OF 24**
- A South African sports drink brand developed to provide rapid hydration, electrolytes (sodium and potassium), and carbohydrates to replace fluids and energy lost during physical activity. It is available in Ready-to-Drink (RTD) bottles, concentrates, and zero-sugar variations.
- Key Specifications and Features
- Product Type: Isotonic Sports Drink
- Sizes: 500ml (single or 6-pack) and 750ml (concentrate)
- Electrolytes: Contains Sodium and Potassium

ITEM 3: ENERGY BARS 45G IN A STANDARD BOX

Energy Bars are high-protein, vitamin-enriched, and mineral-supplemented bars designed for energy and recovery. They are available in various pack sizes, with the most common being 45g bars (often in 20-240 unit boxes) and 20g "Bite Size" bars.

writing from all bidders before the validity expiry date. Extension of validity shall be finalized while the quotations/bids are still valid.

7. MARKET ANALYSIS

The City of Tshwane reserves the right to conduct a market analysis. Should the City exercise this option, where a bidder offers a price that is deemed not to be viable to supply goods or services as required, written confirmation will be made with the bidder to seek confirmation of whether the bidder will be disqualified based on being non-responsive. If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the service provider to deliver will be handled in terms of the contract including performance warnings and listing on the database of restricted suppliers.

The City further reserves the right to negotiate a market related price with a bidder scoring the highest points. If the bidder does not agree to a market-related price, the City reserves the right to negotiate a market-related price with the bidder scoring the second highest points, if the bidder the second highest points does not agree to a market-related price, the City will negotiate a market-related price with the tenderer scoring the third highest points. If a market-related price is not agreed, the City reserves the right to cancel the quotation.

 - (c) provides the same goods and services as the bidder and/or is in the same line of business as the bidder

6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium³ will not be construed as collusive bidding.
7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
 - (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)
 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
 - (f) bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
