### **Purchase, collect and remove melted, burnt and powder ferrous metal steel at tutuka power station on a once off agreement**

- The successful tenderer will be required to pay upfront for the allocated batch and collect all units within 7 working days from the issue date of the approved work instruction / task order and after collection.
