BACKGROUND AND OVERVIEW OF THE PROJECT

1.1 INTRODUCTION

The Winnie Madikizela Mandela Local Municipality is entrusted with the responsibility to oversee the implementation of the Disaster Management Amendment Act, 2015 (Act 16 of 2015) and the National Disaster Management Framework, 2005 (Government Notice 654 of April 2005) throughout the District. Similarly, disaster risk management is a collaborative process involving all spheres of government, NGO's, the private sector, a wide range of capacity building partners and communities. It requires capabilities to continuously and on an on- going basis, to effectively anticipate, prepare for, respond to and monitor a range of natural and other hazards. The Winnie Madikizela Mandela Local Municipality is seeking to engage a contractor for Honey sucking of the following facilities if and when necessary for the period of 36 months:

- **Taxi Rank**
- **Mphuthumi Mafumbatha Stadium**
- **Mbizana Main Library**
- **Multi-Purpose Youth Centre**
- **Mbizana Cemetery**
- **Mbizana Community Park**
- **Civic Centre**
- **Ebenezer Library**

Toilets are potentially a risk for transmission of the virus if not managed well. The decision to source honey sucking services is to reduce the risk of diseases that can be caused by unmonitored health hazards.

1.2 OVERALL AND SPECIFIC OBJECTIVES OF THE PROJECT

1.2.1 Overall objective

Communities are at a high risk of exposure to harmful health hazards due to non-availability overflow of sewer this therefore seeks to ensure that our communities are safe in and around these facilities.

1.2.2 Specific Objectives

The specific objectives of the project require the undertaking of the following:

- Ensuring the availability or resources for infection prevention and control measures
- Reducing the spread of pathogens and reducing the contamination of surfaces and inanimate objects

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

(a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
