1. BACKGROUND INFORMATION

Bidders with 2ME PE or higher are invited to bid for the installation and maintenance of air conditioners for a period of 36 months.

2. SCOPE OF WORK

- 2.1.1 Capricorn District Municipality hereby invites bids for maintenance and installation of air conditioners.
- 2.1.2 Servicing of air conditioners must be done every three months inclusive of gas top-up.
- 2.1.3 The installation must include piping for water extraction to the outside.
- 2.1.4 Only kilometres in excess of 30 must be charged.
- 2.1.5 A copy of purchase receipt of material if required must be attached to the service provider's invoice.
- 2.1.6 The municipality reserves the right to require certificate of compliance for new installation.

4. EVALUATION CRITERIA

The project will be evaluated in two phases, functionality and preferential point system of **80/20 point** system.

4.1 PHASE 1: FUNCTIONALITY

Bidders must score a minimum of 80 points to proceed to the next phase of evaluation.

5. SPECIAL CONDITIONS

Bidders are expected to have a minimum of CIDB grading 2ME PE or higher, failure to adhere to this requirement will lead to automatic disqualification.

6. PROJECT DURATION

The appointed bidder will sign a 36 months' service level agreement with the municipality.

8. CONDITIONS FOR THE BID

- 8.1 The employer and each Bidder submitting a Bid offer shall comply with these terms and conditions of Bid. In their dealings with each other, they shall discharge their duties and obligations timeously and with integrity, and behave equitably, honestly and transparently.
- 8.2 The bidder must attach following with the tender:
 - 8.2.1 The legal registration certificates of the business entity.
 - 8.2.2 Tax access code (pin) issued by the South African Revenue Services to verify your tax matters.
 - 8.2.3 B-BBEE certificate or SWORN affidavit from Commissioner of Oath
 - 8.2.4 Proof of registration with professional authorities. **(Where Applicable)** proof of registration with the central supplier database (CSD)
 - 8.2.5 Proof that municipal rates and taxes are not in arrears/lease agreement/ letter from traditional council
- 8.3 **The bidder must complete the attached forms** (failure to do so will result to disqualification)

- 8.4 Bidders must take note that briefing session will not take place. Bidders may send electronic mails enquiries related to this bid. The bid price must remain valid for a period of 90 days calculated from the closing days.
- 8.5 The offer shall be open for acceptance by the Municipality during the validity period of 90 days.
- 8.6 The bidder or any of its directors has not:
 - 8.6.1 Listed on the register of bid defaulters in terms of the Prevention and Combating of Corrupt Activities Act of 2004 as a person prohibited from doing business with the state.
 - 8.6.2 Abused the employers supply chain management system.
 - 8.6.3 Failed to perform on any previous contract and has been given a written notice in this effect.

- 8.6.4 All information and details must be legible/ readable.
- 8.7 If the bidder fails to fulfil the contract when called upon to do so, the municipality may, without prejudice to its other rights, withdraw or cancel the contract that may have been entered into between the bidder and the Municipality.
- 8.8 Each communication between the Municipality and a Bidder shall be to or from the Municipality only, and in a form that can be read, copied and recorded. Writing shall be in the English language. The Municipality shall not take any responsibility for non-receipt of communications from or by a Bidder. The name and contact details of the Municipality are stated.
- 8.9 Accept that the employer will not compensate the Bidder for any costs incurred in the preparation and submission of a Bid offer, including the costs to demonstrate that aspects of the offer satisfy requirements.
- 8.10 The Municipality may accept or reject any variation, deviation, bid offer or alternative Bid offer, and may cancel the Bid process and reject all Bid offers at any time before the formation of a contract. The employer shall not accept or incur any liability to a Bidder for such cancellation and rejection but will give written reasons for such action upon written request to do so.
- 8.11 No bids will be considered from persons in the service of the state (as defined in regulation 1 of the local government: municipal supply chain management regulations)
- 8.12 Bid documents may not be retyped, redrafted or copied. Only original copy from the municipality will be accepted.
- 8.13 Use of correctional fluid is prohibited
- 8.14 Any alteration made by the bidder must be initialled.
- 8.15 The bidder must ensure that all pages of the tender documents are initialled.
- 8.16 Successful bidder will be required to enter into formal contract with the municipality.
