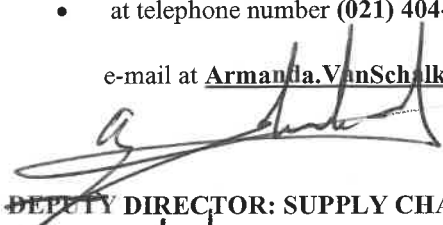

#### **1. DELIVERY LOCATIONS**

- 1.1 Goods are required for delivery to the Main Kitchen, A-floor, A22 of Groote Schuur Hospital, an institution under the control of the Department of Health, Western Cape Government in such quantities as specified in the bid specification/pricing schedules. It is essential that sufficient stock be on hand.

#### **2. DELIVERY AND DOCUMENTS (GCC Par. 10.1 and 10.2)**

- 2.1 Weekly orders will be placed for delivery, products must be delivered to the Main Kitchen from Monday to Friday between 7h30 and 12h30 as requested on the order. Products must be transported and delivered in a refrigerated truck with a temperature not exceeding -7 Celsius. The truck must contain meat products only and no halaal products to be delivered with non-halaal products, **in line with point number 10, 11 and 12 of the specification.**
- 2.2 Where unlimited quantities cannot be delivered within the delivery periods quoted, bidders should indicate the rate of delivery per week or per month that can be maintained, please.

#### **3. ORDERING RESTRICTIONS**

- 3.1 Groote Schuur Hospital shall not be restricted to minimum quantity orders.

#### **4. QUANTITIES**

- 4.1 The quantities reflected in the bid forms are quantities specified but not guaranteed and will be determined solely by the requirements of Groote Schuur Hospital.

#### **5. SAMPLING**

- 5.1 A sample must be provided to the Main Kitchen before the closing date and the product offered on the bid supplied in terms of the contract **must not differ** from the sample, **in line with point number 9 and 15 of the specification.**

**6. SUPPORTING DOCUMENTS**

6.1 All items in this bid require **valid original or certified copies** of the following compliance documents in their bid documents **by bid closing**:

- i) Certified Hazard Analysis for Critical Control Points (HACCP) Compliance certificate from the manufacturer of the product. If repacking, repackaging, and/or any processing are done by the bidder then a HACCP certificate in the name of the bidder will be required.
- ii) The bidder to indicate whether the product is delivered from their own premises or from the manufacturer directly.
- iii) Certified Halaal Certificate for the product offered and for the bidder's premises as well as the transport of the products and or the halaal certificate of the manufacturer if it differs from the bidder's premises.
- iv) Certified Certificate of Acceptability for the bidders' premises, from the city council. COA must be in the bidder's name and thus no third-party COA will be accepted.

**PLEASE NOTE:**

- **If the bidder does not provide all the supporting document as requested the bid will be deemed non-compliant.**

**7. PRICES (GCC Par. 17)**

- 7.1 All prices quoted must include delivery to the various stores as indicated in paragraph 1 above.
- 7.2 **Bid prices shall be quoted nett and VAT INCLUSIVE.** Bidders providing a discount may indicate so.

**8. PAYMENT**

8.1 In the interest of security and expeditious payment, it is the policy of the Groote Schuur Hospital to effect payments by electronic funds transfer (EFT) as far as possible. If a successful bidder is not yet a regular participant in Groote Schuur Hospital's contracts and has not been registered already, the supplier will be required to furnish the Groote Schuur Hospital with its banking details for the systems in operation (Logis, BAS, Syspro) in order to be registered. Successful bidders must ensure, therefore, that their banking details are provided to institutions on request where necessary.

8.2 Payment shall be 30 days from receipt of invoice.

8.3 Payment Conditions (GCC Par. 16.1)

Payment in full will be made when the designated Hospital Official confirms in writing that the contract conditions have been complied with and that handover in good working order has been received.

8.4 Payment Currency (GCC Par. 16.4)

Payment will only be made in Rands in the Republic of South Africa.

**13.1 Mediation Proceedings (GCC Par.27.1)**

- The mediation shall be informal. The Head: Department of Health shall have the absolute discretion to determine the procedure to be followed.

The National Industrial Participation (NIP) Programme, which is applicable to all government procurement contracts that have an imported content, became effective on 1 September 1996. The NIP policy and guidelines were fully endorsed by Cabinet on 30 April 1997. **15. Warranty**

- 15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's

23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

**27. Settlement of disputes**

27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.

**32. Taxes and duties**

32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.

32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.

32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.

**33. National Industrial Participation (NIP) Programme**

33.1 The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation.

**34. Prohibition of Restrictive practices**

34.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder (s) is / are or a contractor(s) was / were involved in collusive bidding (or bid rigging).

34.2 If a bidder(s) or contractor(s), based on reasonable grounds or evidence obtained by the purchaser, has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.
