The Nkomazi Municipality invites proposals from accredited training service providers for skills development programmes of Nkomazi Local Municipality.

A compulsory tenderer briefing session will be held on [10/05/2023](#) at 10H00 at the Municipal Town Hall Malalane (Kobwa Hall) at Fish Eagle. It is advisable that Service Providers do attend the briefing session as it is compulsory, for explanation and clarity service providers are encouraged to attend. Those who will not make it on the briefing would be penalized.

Bidders are advised not to commit fraudulent activities or forge document, all abusers of the SCM System, including or faking of returnable documents, maybe reported to SAPS or restricted from doing business with any Public Institution for a period not exceeding 10years in line with section 28 and 29 of the prevention and combating of corrupt activities Act 12 of 2004.

A preferential system shall apply whereby this contract will be allocated to a bidder in accordance with the Preferential Procurement Framework Act, no 5 of 2000 and as defined in the bid document, read in conjunction with the Preferential Regulation, 2022 where 80 points will be allocated in respect of price and 20 points in respect of targeted goals. 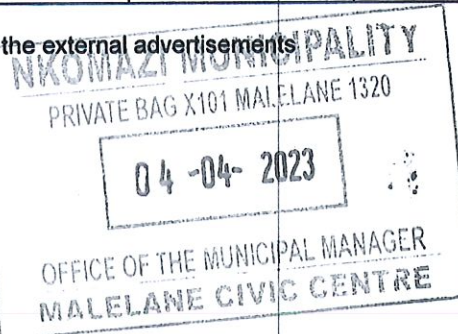
