The Greater Kokstad Municipality hereby invites service provider for the Appointment of a Service Provider for the Refurbishing and furnishing of existing Park home modular office.

The scope of work and bid requirements is stipulated in the bid document.

Evaluation will be done following two-stage process in terms of National Treasury Circular No: 53:

Stage 1:

Assessment of Functionality. Only service providers who achieve a minimum of 50 points of the total available points will qualify for stage two of the Evaluation process. Functionality criteria is as follows:

Company Experience	(40 points)
Financial Viability	(30 points)

Stage 2:

The 80/20 preferential point system will be applied, where 80 points will be allocated for price and 20 points for B-BBEE Status. Bidders must submit a certified certificate issued by an Accounting Officer as contemplated in the CCA or a Verification Agency accredited by SANAS, Registered Auditor or sworn affidavit to claim preference points.

Only tenders who meet the following prequalification criteria may respond.

- (i) At least BBBEE Level 1 to Level 3

POINTS AWARDED FOR B-BBEE STATUS LEVEL OF CONTRIBUTOR

In terms of Regulation 6 (2) and 7 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

B-BBEE Status Level of Contributor	Number of points (80/20 system)
1	20
2	18
3	14
Non-compliant contributor	0
