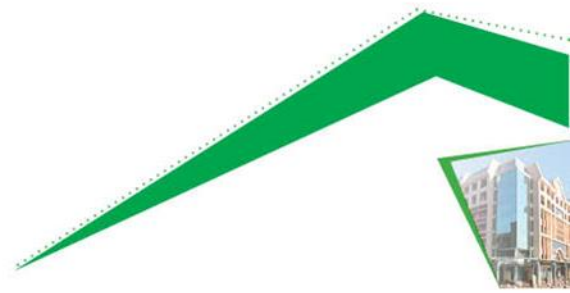

T1.1 Tender Notice and Invitation to Tender

The Eastern Cape Department Public Works and Infrastructure invites Professional Service Providers for the **PROVISION OF PROFESSIONAL CIVIL AND STRUCTURAL ENGINEERING SERVICES FOR THE ALTERATION AND ADDITION TO COFIMVABA HOSPITAL IN CHRIS HANI – COFIMVABA FOR A PERIOD OF (48) MONTHS CONTRACT.**

Eastern Cape Department of Public Works and Infrastructure will enter into a contract with the successful tenderer.

The contract will be based on the CIDB Professional services contract (Third edition) 2009.

Only tenderers who have suitable experience and suitably qualified personnel in providing similar services to those that are required are eligible to submit tenders.

Tender documents will be emailed to nominated bidders on the **20 July 2022.**

The closing time for receipt of tenders by the ECDPWI is 11:00am on **18 August 2022.**
