Office of the premier seeks to appoint reputable service provider to train 40 officials on Presentation and communication Skills training.

2. PROJECT SCOPE

The service provider is expected to cover on the following but not limited to the following:

- Effective Communication
- Understanding your audience
- Non-verbal Communication
- Presentation skills
- Presenting information clearly and effectively
- Delivering your presentation
- Using a mind map
- Feedback and evaluation of your presentation
- Getting clear message across.

3. COURSE OUTCOME

After completing the course, the delegates should be able to: -

- Understand the purpose of presentation.
- Strategically plan presentation based upon an audience analysis.
- Apply verbal skills to capture and maintain audience interest.
- Apply critical listening skills and respond confidently to questions.
- Develop awareness of how effective non-verbal messages are communicated.
- Improve your written communication skills, using memos, emails and reports.
- Overcoming blocks - using mind maps for designing your power point presentation.
- Hearing your Speaking Voice, tone, articulation, pitch and volume.
- Speaking with energy.

- Provide theoretical tuition, facilitate the development of portfolios of evidence and prepare learners for all the required formative and summative assessments.
- The course must be a soft skills training.
- Use of blended approaches to learning such as role-plays, assimilation activities and exposure to case studies relevant to Public Sector, exposure to latest digital platforms is mandatory during facilitation.
- An institution accredited credit-bearing course aligned to a Unit Standard.
