Therefore, these technicians are not protected as they work on such terrain, weather conditions, and construction sites.

3. PURPOSE FOR THE PROJECT

The main purpose of the protective clothing is to exercise safety precautions as stipulated on Occupational Health and Safety Act of 1993 and avoid injuries on duty that may occur.

 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.
